Board Meeting Minutes

Jason Walker presented five new contracts for 2013 Ag. Cost Share. Contract #99-2013-001 was for a spreader truck for \$10,500. Contract #99-2013-002 was for a water system, \$10,645 will be paid using cost funds and \$10,000 will be paid using the High Rock Lake Grant. Contract #99-2013-003 was for a spreader truck for \$10,500. Contract #99-2013-004 was for a spreader truck for \$7,155. Contract #99-2013-005 was for a spreader truck for \$10,500. Van Hemric made a motion to approve all contracts and conservation plans with them. Bobby J. Matthews Jr. seconded the motion. Motion Carried.

Leigh Calloway reminded the board about the upcoming area 2 spring meeting. It is scheduled for March 14, 2013 in Catawba County. Pre-registration is due by March 1, 2013.
