Conservation Plan – The conservation plan for contract 99-2025-802 was presented for approval. Greg Moxley motioned to approve the conservation plan and Jo Linville seconded. Motion carried 4 – 0.

USDA Conservation Plans – Lance Parker presented USDA conservation plans for approval. Van Hemric motioned to approve the conservation plans and Jo Linville seconded. Motion carried 4 – 0.

Lenuel Chamberlain asked if there was any additional business to discuss. No new business was presented.

Jo Linville motioned to adjourn the meeting and Greg Moxley seconded. Motion carried 4 – 0.
