

## AMENDMENT TO HUGH CHATHAM MEMORIAL HOSPITAL

This Contract Amendment is made and entered into this 1st day of June 2015 ("Effective Date") between Yadkin County, North Carolina ("County") and Hugh Chatham Memorial Hospital. ("Provider").

WHEREAS, the County and the Provider wish to enter into a contract under which the Provider will provide certain specified services and/or materials to the County in exchange for payment. NOW, THEREFORE, in consideration of the mutual covenants, promises, terms, conditions, and agreements herein, the County and the Provider agree to amend the Hugh Chatham Memorial Hospital Services Agreement Effective June 1, 2015 as follows:

1. The terms of the contract are outlined in Amendment I (attached).
2. All other terms and conditions set forth in the original agreement shall remain in effect for the duration of the contract.



## Amendment I

This Agreement shall be for the purpose of providing x-rays to clients referred to the Contractor by the Department under the following conditions:

I. The parties' obligations:

- A. The Yadkin County Medical Clinic agrees to:
  - a. From time to time refer clients to the Contractor for chest x-rays or spinal x-rays, such as those clients:
    - i. With positive PPD
    - ii. Who have had contact with active cases of tuberculosis
    - iii. Those with a doctor's order for an x-ray
  - b. Provide the client with an authorization slip from the Yadkin County Medical Clinic for an x-ray and
  - c. Reimburse Contractor for providing x-rays, not to exceed \$20.00 per x-ray in order to meet standards of the State TB program
  - d. Notwithstanding any other provision in this Agreement, the total amount paid by the Department under this Agreement shall not exceed \$200.00 in any fiscal year (which shall run from June 1 through June 30, 2015).

B. The Contractor agrees:

- a. As requested and authorized by the Yadkin County Medical Clinic for Medical Clinic clients, to take and develop chest and spinal x-rays in a timely manner at the rate stated above;
- b. To obtain payment for the above listed services by billing Medicare, Medicaid, and private insurance as applicable. Only if payment cannot be obtained from those other sources may the Medical Clinic be billed as payor of last resort at the following address:

Each bill should include the Contractor's name, address, Federal Tax Identification Number or Social Security Number, the patient's name, the service provided, the date the service was provided, the cost for each service, and the amount that is due and owing.

- c. The Contractor shall assure that no person, solely on the grounds of race, color, age, religion, sex, or national origin, shall be excluded from participation in, be denied the benefits of, or be subject to discrimination under any program or activity covered by this agreement, and Contractor shall otherwise comply with all applicable laws, regulations, industry standards, and contractual requirements regarding non-discrimination.

d. The Contractor shall assure that no otherwise qualified handicapped individual, solely by the reason of his/her handicap, shall be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity covered by this Agreement, and Contractor shall otherwise comply with all applicable laws, regulations, industry standards, and contractual requirements regarding non-discrimination.
