AMENDMENT TO OWNER-ENGINEER AGREEMENT

Amendment No. 1

1. Additional Services for Booster Pumping Station

During the planning phase of the project DMP worked with the County to identify a location for the proposed booster pumping station (BPS). The Forbush VFD property was identified as a potential site and the County agreed this was a suitable location and an agreement was made with the VFD. With all parties in agreement, DMP proceeded with design of the BPS. At the completion of design, DMP prepared permit applications which were submitted by the County to NCDOT for an encroachment permit and NCDENR for an Erosion and Sedimentation Control permit and both permits received approval. After design was complete and permits approved, the VFD altered their request and

ultimately backed out on the original agreement for the BPS to be located on the back corner of their property.

Since the the time that the VFD withdrew from the agreement for the County to utilize the VFD property DMP has assisted the County with identifying a suitable location for the BPS including additional hydraulic computer modeling to determine a suitable location. DMP has reviewed and provided preliminary evaluation, site plans and/or additional computer hydraulic modeling and environmental review, for over ten sites in an attempt to find a suitable location that would work both hydraulically as well as be feasibly acceptable by the local residents/property owners.

In addition to providing design/planning related assistance to finding a suitable site for the BPS, now that the County has agreed to purchase a piece of property from the Gough's for the location of the BPS , DMP will need to perform design services including amendments to the previously approved (NCDOT) and (NCDENR) permits.

The design services related to assisting the County with finding a suitable location for the BPS and completing design for the current location, including permit amendments, are considered additional services.

DMP is requesting an amendment to the original contract in the amount of \$11,850 for these additional services.


