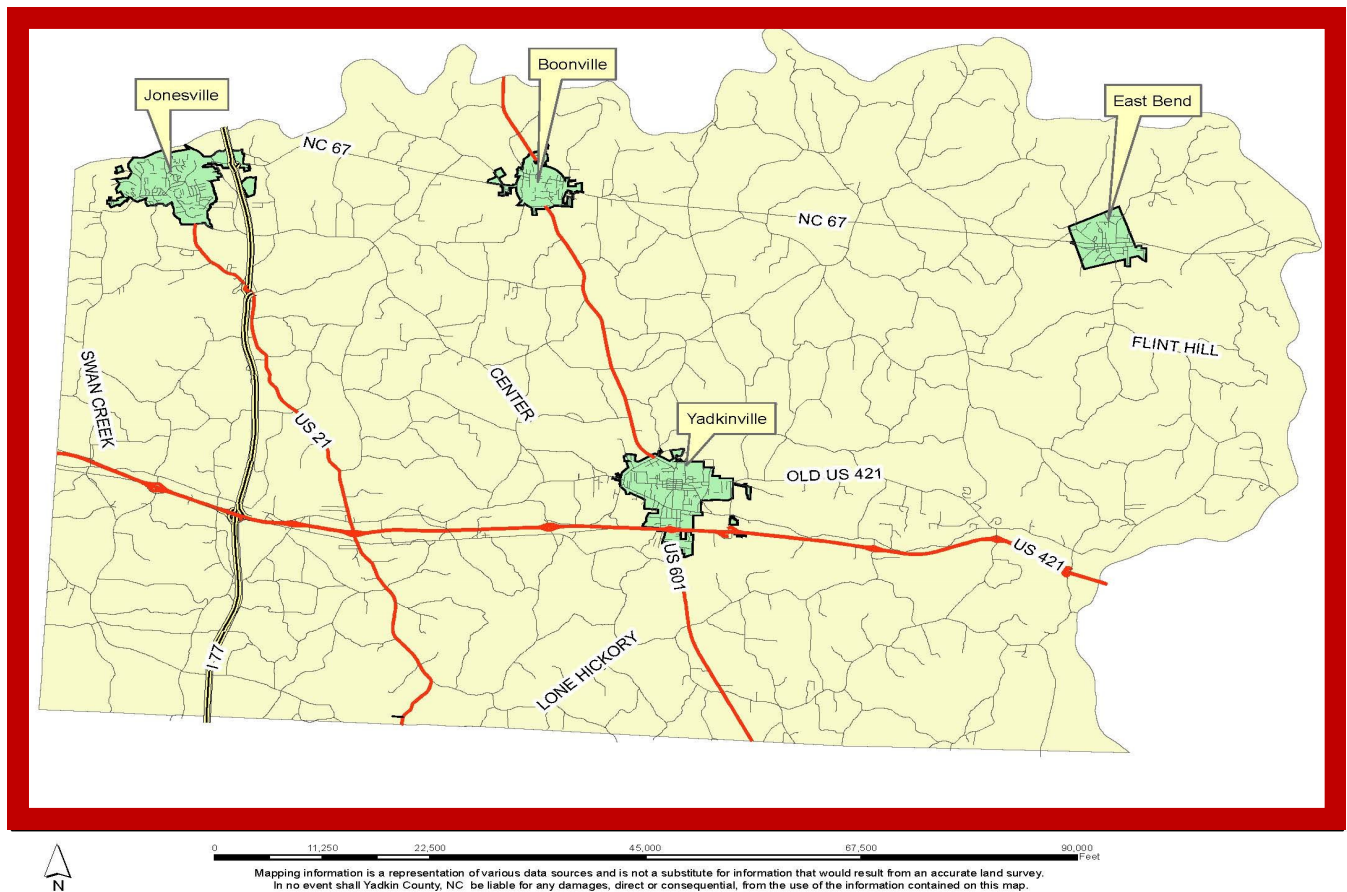

Yadkin County, incorporated in 1850, is located in the Piedmont section of North Carolina. Yadkin County is bounded on the north by Surry County and Stokes County, on the east by Forsyth County, on the south by Davie County and Iredell County, and on the west by Wilkes County. With a land area of approximately 337.77 square miles, the County is known for its vast agricultural lifestyle and the Yadkin River. The County serves a population of 38,004 residents (2014 OSBM estimate), with the County seat being located in Yadkinville. Also located within the County are the Towns of Boonville, East Bend and Jonesville.

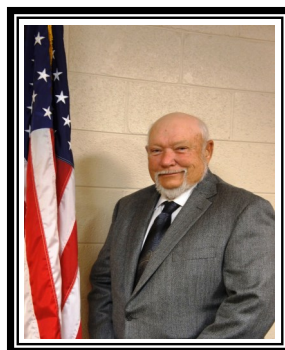
This report will highlight the statutory required reporting of the finances and administrative activities of the County per North Carolina General Statute 153A-82(6).

Over the last year, we have continued to make enhancements to Memorial Park, begun construction on the Yadkin County Agricultural and Educational Building. Completion is expected in late spring 2016 and Naming Opportunities are available now.

We received a low interest Drinking Water State Revolving Fund loan to fund the East Bend Waterline Project and anticipate construction bids being issued in late spring 2016.

The sudden closure of the hospital by HMC/CAH Consolidated, Inc. impacted us all. We have worked diligently to seek another operator for the hospital and have sought to obtain the Legacy Medical Care Facility designation from the State. Our hopes are to have more healthcare options available to citizens within our community, without having to travel to Winston Salem or Elkin.

FY2015 was a busy year, with many challenges and accomplishments and we managed to keep the tax rate flat in FY2016. In closing, thank you for being a part of our County and for allowing us to serve you.

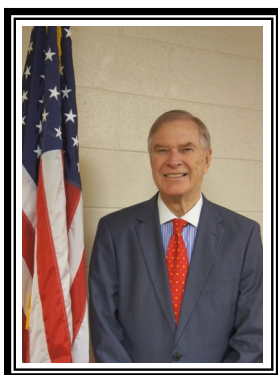

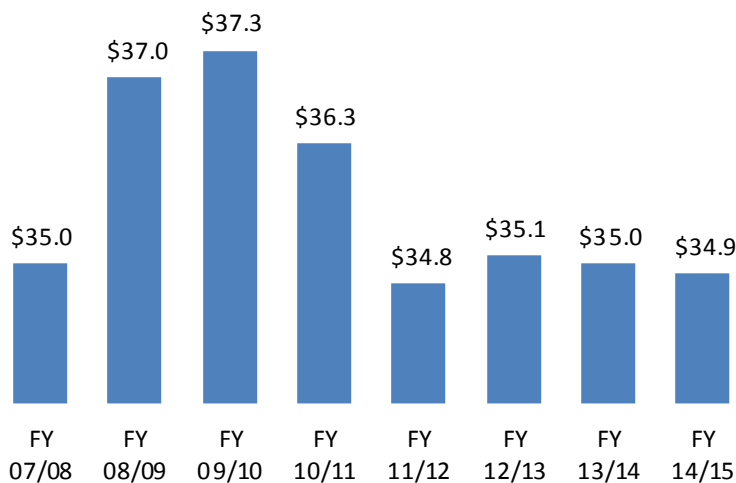

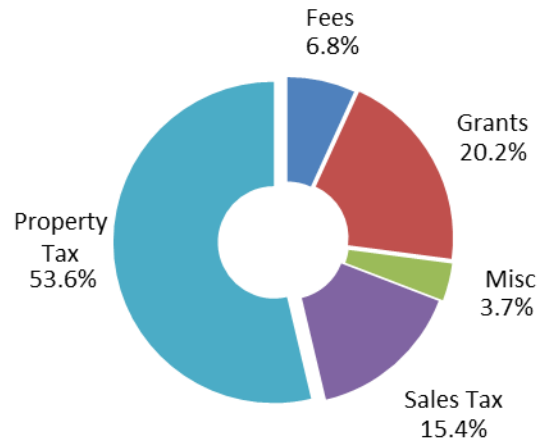
Finance Department

The Fiscal Year 2015 adopted budget for the County of Yadkin totaled \$34,998,741. The budget was an increase of four (4%) percent. However, the budget contained no county-wide tax increase and the rate remained sixty-six cents per \$100.00 assessed valuation.

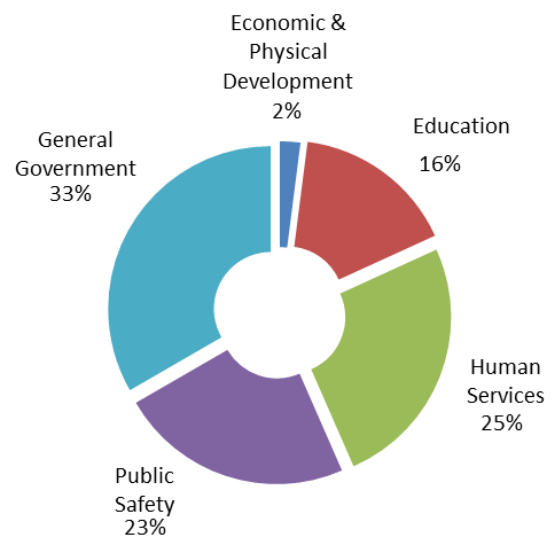
Over the past four years the Finance Department, County Manager and the Board of Commissioners have worked vigorously to maintain a budget with minimal increases. A timeline of the past eight fiscal year budgets can be seen below, with the budget shown in millions.

The County of Yadkin received an unmodified opinion from the firm of Martin Starnes & Associates for the Fiscal Year 2015. "That was a clean opinion and the best that can be given", as stated by Jill Vang of Martin Starnes. (Yadkin Ripple)

Did you know you can receive a 2% discount for early payment of ad valorem taxes? Just pay your taxes during the month of August after receiving your bill.

The 2015 tax rate for Yadkin County remained at \$0.66 per \$100 valuation of estimated taxable property situated in the County as of January 1, 2015. The formula used to figure your real and personal property tax is as follows:

$$\text{Property Value } \$150,000.00 \div 100 \times 0.660 = \$990.00$$

The ad valorem tax is based on a total estimated real and personal property valuation of \$2,522,858,932 with an expected collection rate of 95.62%. The next reappraisal of your property is scheduled for 2017.

The total estimated motor vehicle valuation is \$2,486,498 with an expected collection rate of 100%.

In addition to the property tax you are billed a fire service tax that is collected by the County and forwarded to each fire department. The rates are requested by each fire department and approved by the County Commissioners. These funds are to be used for the operation of your local fire department. The 2015 Fire tax rates are:

Human Services Agency

The Yadkin County Human Services Agency was formed in 2013. This County department is comprised of the Social Services Division, the Women, Infant, and Children Division, the Medical Clinic and the Animal Shelter. The mission of the Human Services Agency is to protect and improve the health and quality of life of the citizens of Yadkin County. This is accomplished through the strengthening of families, promotion of self-sufficiency, eliminating poverty, assuring and maintaining a healthy environment, education of the people, providing preventative health services and enforcing state rules and regulations.

The Social Services Division provides assistance through the Food and Nutrition, Adult Medicaid, Family/Children's Medicaid, Subsidized Child Care, and other special assistance programs like the CIP and LIEAP programs. This Division is also tasked with protecting children through Child Protective Services, Foster Care & Adoption Services, as well as the elderly and disabled adults through Adult Protective Services and the monitoring of the four adult care homes in the County. Child Support Enforcement services are available to any individual who has custody of a child who needs support.

WIC and the Medical Clinic provide services through state and federally funded programs. WIC is a Special Supplemental Nutrition Program for women, infants, and children (WIC) funded by the United States Department of Agriculture (USDA). The Medical Clinic has programs that include: Breast and Cervical Cancer Prevention, Child Health, Communicable Disease/STD, Family Planning, Immunization, and Maternal Health. The enrollment for these programs is based on certain criteria.

The Yadkin County Animal Shelter includes 21 dog kennels, 18 cat kennels, and an adoptable cat room called the "Catty Shack", which can house 12 cats. We have both cats and dogs that have become separated from their owners. Our first priority is to try to locate the animal's owner and reunite them with their family. If we are unable to locate an owner, we work on placing these animals in homes through adoption or our work with rescue groups. We work closely with the Yadkin County Sheriff's Office Animal Control Division. The Shelter also has the following programs: Volunteer, Foster, and Community Spay/Neuter.

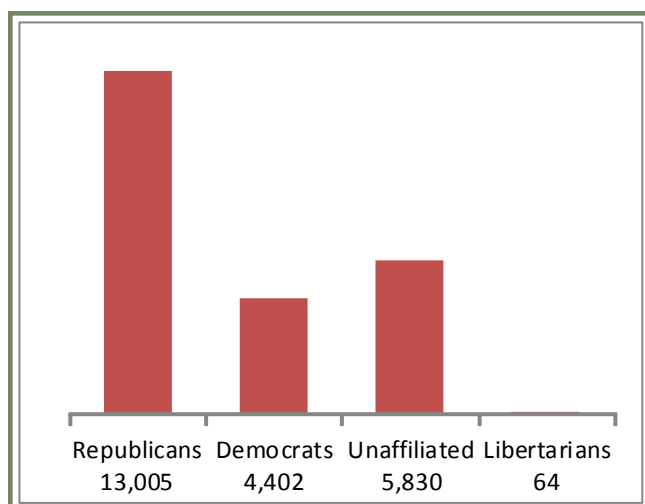

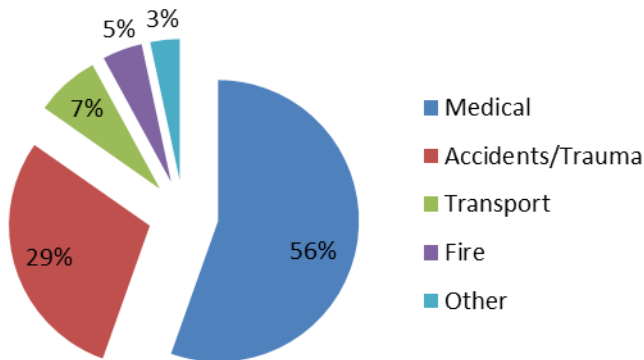

Emergency Services

Emergency Services contains three (3) divisions: Emergency Management, Emergency Medical Services and Fire Marshal. Emergency Services is in charge of the Emergency Operations Center (EOC) located at their main office at 108 George Street, Yadkinville, NC 27055. Our goal is to deliver the most advanced pre-hospital care possible to the citizens of Yadkin County, and to those who travel, work and recreate within our boundaries. Throughout the past year Yadkin County has responded to calls of various natures as defined below.

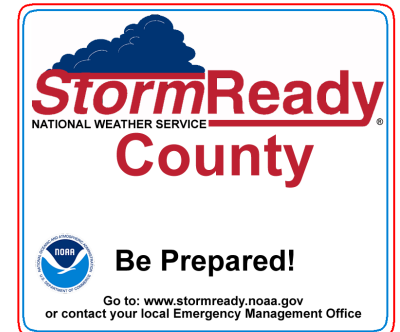
Accidents/Trauma - wrecks, falls, physical injury

In October 2014 all 100 Counties were challenged by Director Mike Sprayberry of NC Emergency Management to become a Storm Ready County. This is a recognition for completing criteria to prepare our county and citizens for better storm survivability. Yadkin County Emergency Management started working on this project at that time. We received our Storm Ready Accreditation on April 20, 2015. In this process we achieved goals in being better prepared to handle large scale and catastrophic storm events and the ability to better warn our citizens of the approaching danger.

It is time once again to reflect on the past year and set new goals for the Sheriff's Office for 2016. The Sheriff's Office employees worked hard last year and continued to make drug enforcement, property crimes, and crime prevention our priorities. We continued our efforts to provide professional, effective and cost efficient services to the citizens of this county.

The Sheriff's Office was able to complete the goals that I mentioned in last year's report. The old detention center renovations were completed and now all inmates, male and female, are being confined here in Yadkin County. Thousands of dollars have been saved in transportation costs and paying for bed space in other counties. The Yadkin County Detention Center now generates revenue renting beds to other counties. The Animal Control Division was added to the Sheriff's Office and was fully operational in January of last year. Now deputies are available 7 days a week to answer animal complaints, pick up animals if needed, and investigate reports of abuse and cruelty. The Sheriff's Office received 3018 animal related calls last year. Our crime prevention program continued to grow and we have almost completed adding all Yadkin County churches and places of worship to the Building Identification Program. New information and handouts on domestic violence are available to the public and a program on proper care of animals is now being presented. During the past year the Sheriff's Office presented over 340 programs on various topics related to crime prevention.

During the past year telecommunicators with the Sheriff's Office received over 50,000 calls for service. When reviewing the charts and statistics from last year you will see the number of persons detained was down slightly however the number of persons arrested was higher than in 2014. If we look at the arrest status by offense you will see robberies increased slightly while assaults and burglaries stayed about the same as the prior year. Drug offenses remained high but were down from the previous year. In last year's report I mentioned that the Sheriff's Office would increase the focus on domestic violence issues and I was happy to see a reduction in domestic violence calls this past year. Applications for handgun purchase permits increased and applications for new concealed carry permits remained about the same as the prior year.

As I reflect on the past year the Sheriff's Office employees have accomplished a great deal and worked hard to make Yadkin County a safer place to call home. I am proud of the telecommunicators, deputies, detectives, detention officers and office staff that have all come together as a team to deliver professional law enforcement services to the citizens of Yadkin County. I thank them for the job they do and I want to thank all the people in this county that have reported criminal activity, provided information, and took part in crime prevention programs that have made our efforts to serve you more effective.

Last year was a disturbing time for all law enforcement officers across this country. A few unfortunate events led to officer involved shootings which have been questioned. Most all of the deaths could have been prevented had the individuals complied with the officers' demands. If officers make mistakes or unreasonable demands we have a court system to sort those things out and everyone goes home alive. Law enforcement officers are human and do make mistakes but I do not believe any of them put on a badge and go to work intending on killing someone. Extensive media coverage, inappropriate comments from leadership, professional protestors, hate groups, and many other factors have contributed to a great deal of tension and lack of respect for the Law Enforcement Officers across this country. Last year 124 officers died in the line of duty across this country. Of the 42 that were killed by gunfire 6 were killed in ambush attacks.

I am concerned about the direction this country is headed. At a time more people are dying from drug overdose than ever before we continue to decriminalize and legalize drugs. As people are being killed we blame flags, monuments, and firearms none of which have ever killed anyone without an accomplice. Until we start blaming people and holding them responsible for their actions I do not believe things will improve very much. I know here in Yadkin County we have not seen the issues that other areas of the country have experienced but the attitudes, distrust and scrutiny can become contagious.

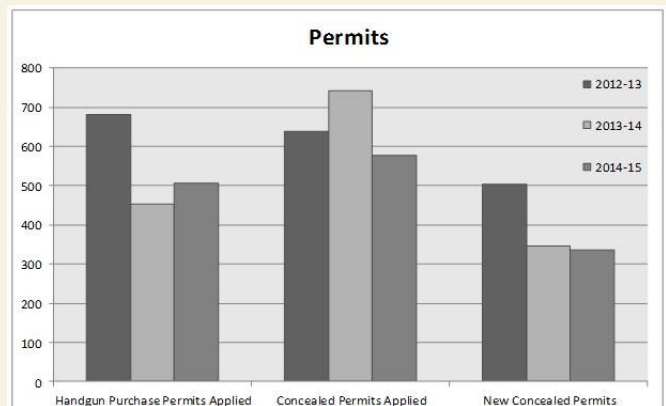
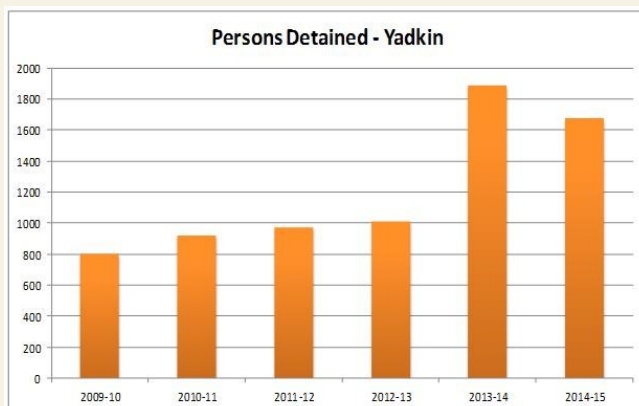
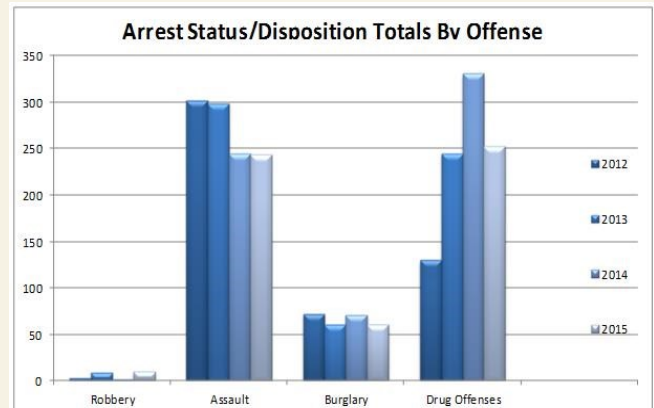
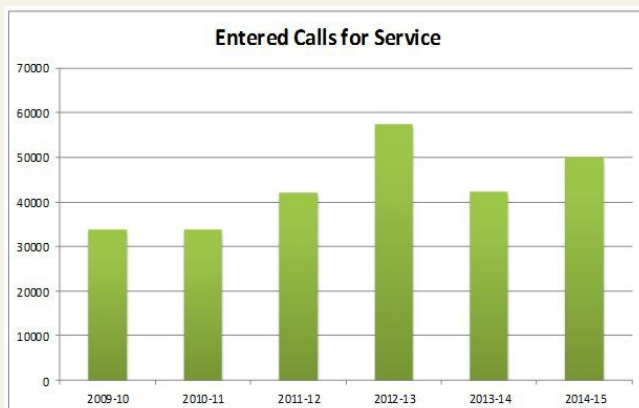
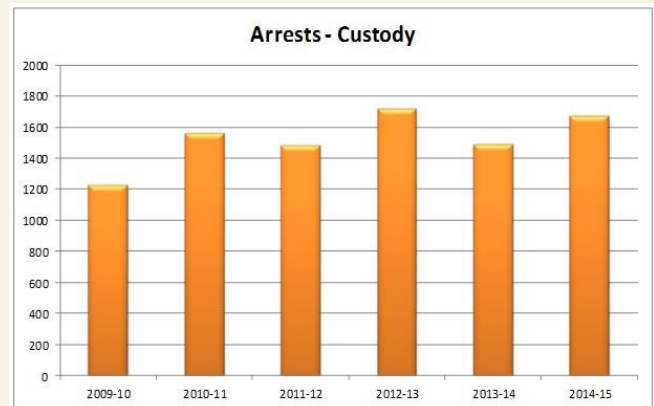
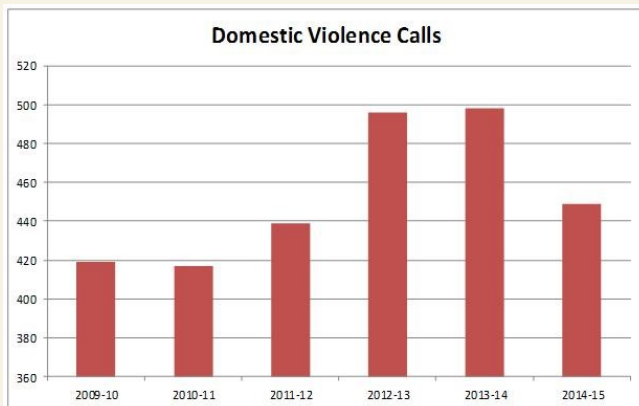
Yadkin County Sheriff's Office

Solid Waste & Recycling

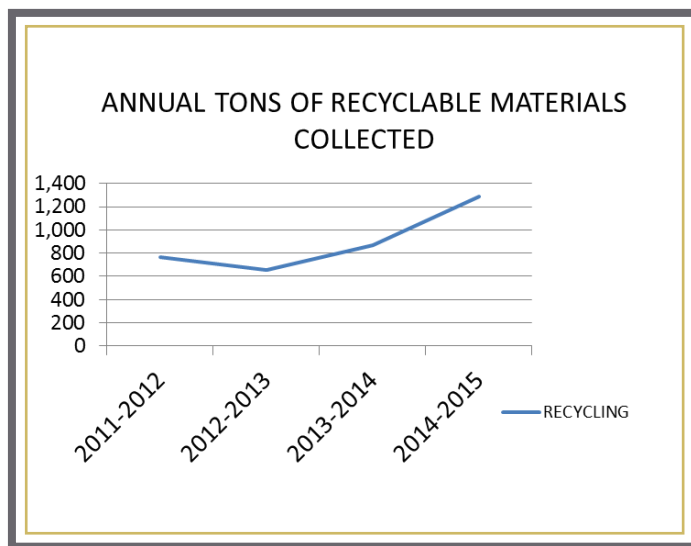
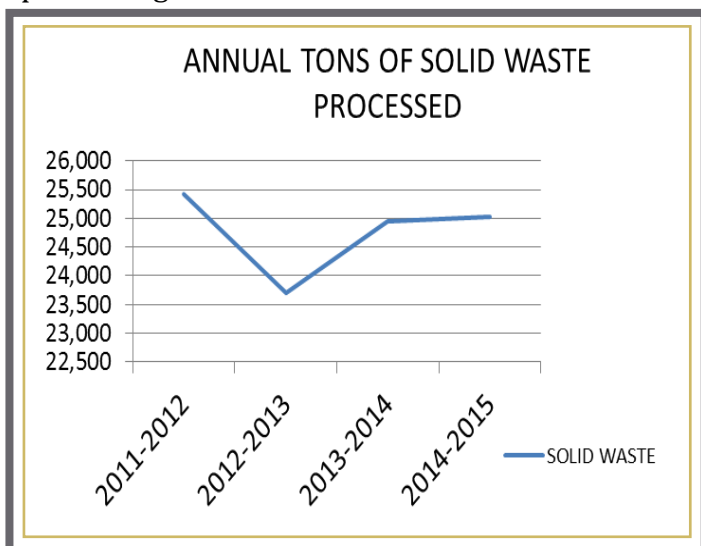
Yadkin County Solid Waste Highlights

- In Fiscal Year 2015, Solid Waste processed approximately 25,030 tons of trash and recycled approximately 598 tons of residential single-stream materials collected from eight convenience sites . The following recyclable materials were recovered from the waste stream:

- Throughout the unincorporated areas of Yadkin County there are over 1,750 public and private roads . Over the past year, 144 road signs were reported missing or damaged and were replaced.
- The recycling area of the Solid Waste Facility located at 1149 Landfill Road, is currently collecting tires that are off the rim. This helps to prevent illegal dumping and provide for a recycling of this commodity. A maximum of five tires per person per year will be accepted without a completed Scrap Tire Certification form. The County is required by the State of North Carolina to certify all tires have been generated in North Carolina. You can obtain this form at the Solid Waste Facility or online at www.yadkincountync.gov.
- In 2014, a decision was made to print the Solid Waste Permit to be valid for a two year period. This decision was primarily made as a cost savings measure for the taxpayers, to reduce the costs associated with printing the stickers annually. Remember to keep the green stickers on your vehicles as they are valid through August 31, 2016. If additional permits are needed or you bought your property in 2015 contact the Tax Department at (336) 679-4221. Owners of rental property are responsible to procure stickers for their tenants.
- The trend as shown in the charts below is a decline in the tonnage of solid waste materials processed annually over the last 4 years and the increase in tonnage for recyclable recovered for processing.

Environmental Services

Building Inspections issues all permits pertaining to new construction, additions, remodeling, and change of occupancy for the County as well as all the Towns within the County. This includes building, electrical, mechanical, plumbing, insulation, sprinkler, fire prevention, and day care permits. After permits are issued, we then follow up with inspections to see that the structures are built according to the plans submitted to our office and by state codes. If the structures are not up to code, we advise about what is needed to meet state requirements.

The Planning and Development Department develops and implements plans and policies supporting sustainable development of land in the County. The Department manages community development activities, performs special studies, and enforces many County development regulations, including: the Subdivision, Zoning, Flood Damage Prevention, and Watershed Protection Ordinances.

The Department also provides technical and administrative support to the Planning Board, Board of Adjustment, and Watershed Review Board. In addition, the department includes Geographical Information Systems (GIS) services, E- 911 addressing assignment, and computerized mapping.

Hospital

On May 22, 2015, we were all impacted with the operators at the hospital HMC/CAH Consolidated, Inc. abruptly closed the hospital at 6:00pm. When the County became aware of their intentions earlier on May 22, our attorneys went to the Courts and obtained a Temporary Restraining Order (TRO) to keep the hospital open. Their attorneys were served and closed the hospital anyway. They have been found in Civil Contempt of the Order by U.S. District Court Judge Terrence Boyle and ordered to pay the County \$148,091.66 in damages and attorney's fees.

The County sold hospital operations to HMC/CAH Consolidated, Inc. in 2010 and entered into a four-year lease agreement with them. The lease agreement was limited to four-years, as their plan was to build another facility and move into that facility by the end of the lease. They never purchased land or made other efforts to build a new facility. The lease was amended three times and extended for a total of fifteen months.

They closed the hospital during the term of the third lease amendment. Legal actions concerning the breach of contract continue in the Federal Court System.

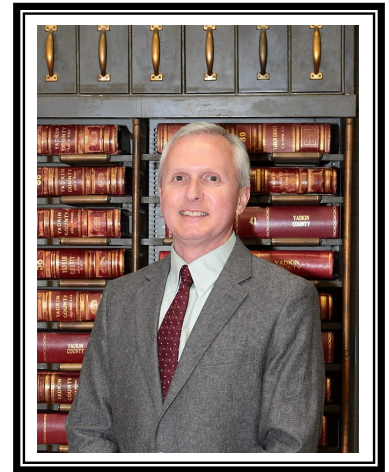
The County has continued to have conversations with potential operators for healthcare services within the County. We asked for, and obtained legislation that will allow us to continue these conversations and secure another operator without having to start the Request for Proposals process required by North Carolina General Statute 131A-13.

Register of Deeds

By law, the Register of Deeds serves as custodian and manager of a large number of public records. The Register of Deeds is legally charged with the integrity, completeness, accuracy and safekeeping of these public records. This amounts to approximately 5,400 documents and plats recorded and 300 marriage licenses issued each year. The documents recorded include Deeds, Deeds of Trust, Powers of Attorneys, Separation Agreements, Plats, Deed of Trust Cancellations and various Agreements. The office also issues certified copies of birth, death and marriage records. The annual revenue collected is approximately \$300,000 for these various records and services.

In Yadkin County we use the most current technology to ensure easy access and retrieval of all our records and provide a courteous and professional environment. Everyday registry employees work tirelessly to ensure that the documents we record reflect the trust that our patrons place in us. This commitment to excellence is the very foundation of our service.

Veteran Services



Veteran Services advises local veterans and their dependents of their rights and entitlements under various federal and state laws, counsels them, and actively assists them by filling out necessary forms and papers, obtaining documents, affidavits and medical records and presenting some before the U.S. Department of Veterans Affairs. The Department assists in gaining admission of eligible veterans to Veteran Hospitals. The County Veteran Services Department also advises and assists service members and their families concerning allotments, financial relief in hardship cases, disability retirement, and other benefits.

Parks & Recreation

Yadkin County Parks and Recreation operates Memorial Park/Lake Hampton, Yadkin County Park, Styers Mill Park, Donnaha Park, Shores River Access and Huntsville River Access.

Yadkin Memorial Park/Lake Hampton: Yadkin Memorial Park and Lake Hampton opened in November, 2014. Yadkin Memorial Park offers an opportunity for citizens to enjoy the outdoors in a tranquil setting. The Park has two picnic shelters, a multipurpose trail, playground, picnic tables, grills, two fishing piers and a boat launch. The Park also offers kayaks and jon boats for rent to use on the lake. Non-gas powered private boats are also allowed to be used on the lake. Yadkin Memorial Park is a registered agent for the NC Wildlife Resources Commission. This means citizens can purchase hunting/fishing license as well as register their boats at Memorial Park. Duck Hunting is offered through a lottery system and information can be obtained at the Park Office. Additional phases of the park are planned and more amenities will be available in the future. The Park is located at 1142 Crystal Lane, Yadkinville, N.C.

Yadkin County Park: Yadkin County Park continues to make improvements to the facilities. The Park offers a swimming pool, playground, sports fields, nature trail, walking trail, fishing pier, two small fishing ponds, amphitheater, disc golf course and two picnic shelters. New parking lots have been installed within the last couple years to allow parking closer to the sports fields. A new fishing pier has been installed within the last year in conjunction with the NC Wildlife Resources Commission. This pier is located at the upper pond at the Yadkin County Park. The pond in which this pier is located is stocked each month from May-October. This allows citizens the opportunity to catch fish all summer. The park is located at 6600 Service Rd, Yadkinville, N.C.

River Access: Yadkin County has three parks that are intended for the citizens to access the Yadkin River. These access points are Donnaha Park, Yadkin Shores River Access and Huntsville River Access. These three points are located at different places where Yadkin County joins the river. These points allow citizens the opportunity to launch a boat or fish at each site. Yadkin County works closely with the NC Wildlife Resources Commission to monitor these locations and provide guidance to the citizens.

We are very excited about the Yadkin County Agricultural and Education Building under construction behind Surry Community College's Yadkin Center on Hwy 601. This building will be home to Surry Community College students on the lower level, which will be accessed by the current Yadkin Center entrance.

The upper level will be accessed by the new Agricultural Way drive entrance north of the current entrance to the Center. The upper level will house NC Cooperative Extension, Soil and Water Conservation District (NRCS), USDA Farm Services Agency and NC Forest Service.

There will also be banquet rooms that will accommodate a total of approximately 300 people seated at round tables with a full commercial or catering kitchen. The banquet rooms will be available to the general public to rent for private, as well as public functions.

The funds received will help maintain the areas and provide equipment/supplies for the commercial kitchen. The Naming Rights also includes complimentary usage of the banquet rooms. 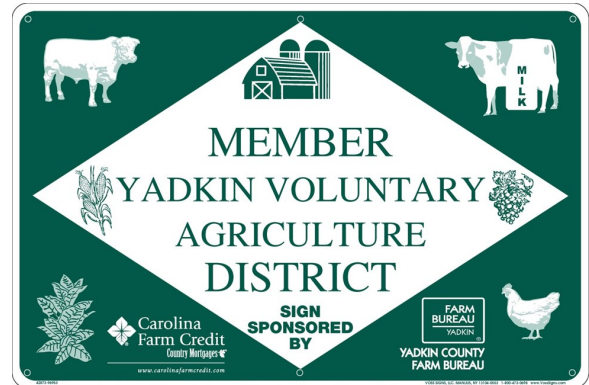
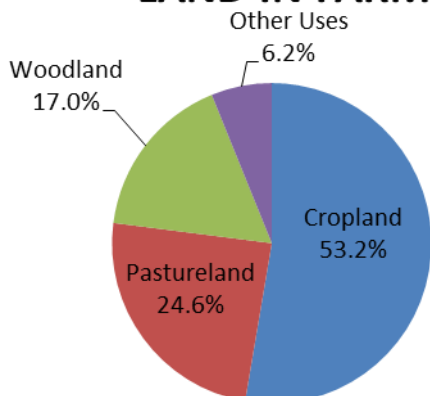

Agriculture remains the dominant industry in Yadkin County, with gross sales of agricultural products just under \$125 million annually, according to the 2012 Census of Agriculture. Although the number of farms continues to decrease like much of North Carolina, agricultural sales and productivity continue to increase. Yadkin County ranks in the top ten of all North Carolina counties for production of hay, beef cattle, dairy cattle, and layers, and approximately half of the county's land area is in farms. 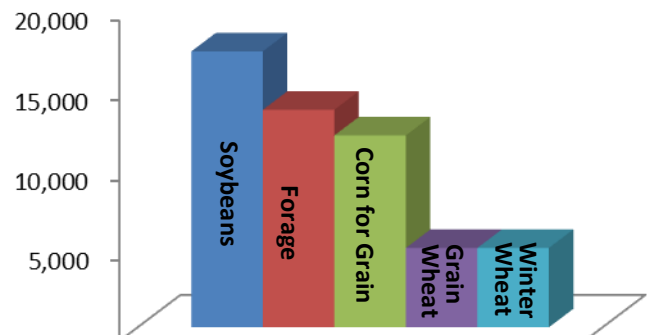

Yadkin County Schools

"Success, Nothing Less"

The Yadkin County School System is comprised of fourteen schools. The eight elementary schools, which serve students in grades kindergarten through six, are Boonville, Courtney, East Bend, Fall Creek, Forbush, Jonesville, West Yadkin, and Yadkinville. Forbush Middle School, located in East Bend, and Starmount Middle School, located in Boonville, serve students in grades seven and eight. Forbush High School and Starmount High School serve the majority of students in grades nine through twelve. In addition, the school system also has the Yadkin Early College High School. The Early College High School provides students with the opportunity to graduate with a high school diploma and an associate's degree. The Yadkin Success Academy, which has students in grades one through twelve, is located in Yadkinville. Our schools are staffed by tremendously talented people who place children first every day. Our teachers, school leaders and other employees work diligently each day to provide the best educational opportunities they can for their students. We are proud that so many wonderful teachers and support personnel choose to work in Yadkin County Schools.

Yadkin County Schools recently completed a 1:1 Initiative with the help of grant funding from the Golden Leaf Foundation. This initiative includes purchasing laptops for all students to use both at school and at home. Students at Forbush High School and Starmount High School now have access to Google Chromebooks and teachers are creating lessons that incorporate the use of technology. Beginning this year, 8th grade students at Forbush Middle School and Starmount Middle School now have Google Chromebooks with the 7th grade scheduled to receive the Chromebooks later this year. Also, students at the Yadkin Early College High School and the Yadkin Success Academy have greater access to technology than ever before. Last year, Yadkin County Schools started a Lego Robotics League for elementary and middle school students. The number of teams for the 2015-2016 school year has grown by 50%. Students will build a robot using Legos and will program the robot to perform specific tasks. These students will also work with mentors from local businesses and industries to learn more about Science, Technology, Engineering, and Math (STEM). This will culminate with a Lego Robotic League tournament in October. The formation of the league was made possible by grant funding from the Northwest Piedmont Workforce Development Board and by the support of local business and industries here in Yadkin County. The Yadkin Early College High School had a 100% graduation rate for the 2014-15 school year. The Early College High School was one of approximately 50 schools from across the state to achieve a 100% graduation rate. Additionally, Yadkin County Schools had its highest graduation rate ever. Yadkin County's high schools had a graduation rate of 89.9%.



Yadkin County Schools would like to congratulate Mrs. Yancy Burklow—2015-2016 Teacher of the Year. Yancy is a product of Yadkin County Schools. She attended school at West Yadkin Elementary and Starmount High School. She earned a scholarship to play softball at Appalachian State University and earned her degree in special education. She said that it was through a series of events in her life that led her to the field of special education. First and foremost was the birth of her nephews, one of which was diagnosed with Cerebral Palsy. Even though he has difficulty walking it does not hold him back. She said that "He truly showed me that disability is only a word, and that word doesn't describe all of his wonderful abilities". After working for one year at Davie High School, Yancy was offered the opportunity to return to her home in Yadkin County and teach in the special education program at Boonville Elementary. Here she works with students who have multiple disabilities, both physical and intellectual. Most are unable to walk and have difficulty communicating, but she works diligently to give her students choices and a voice in their lives.

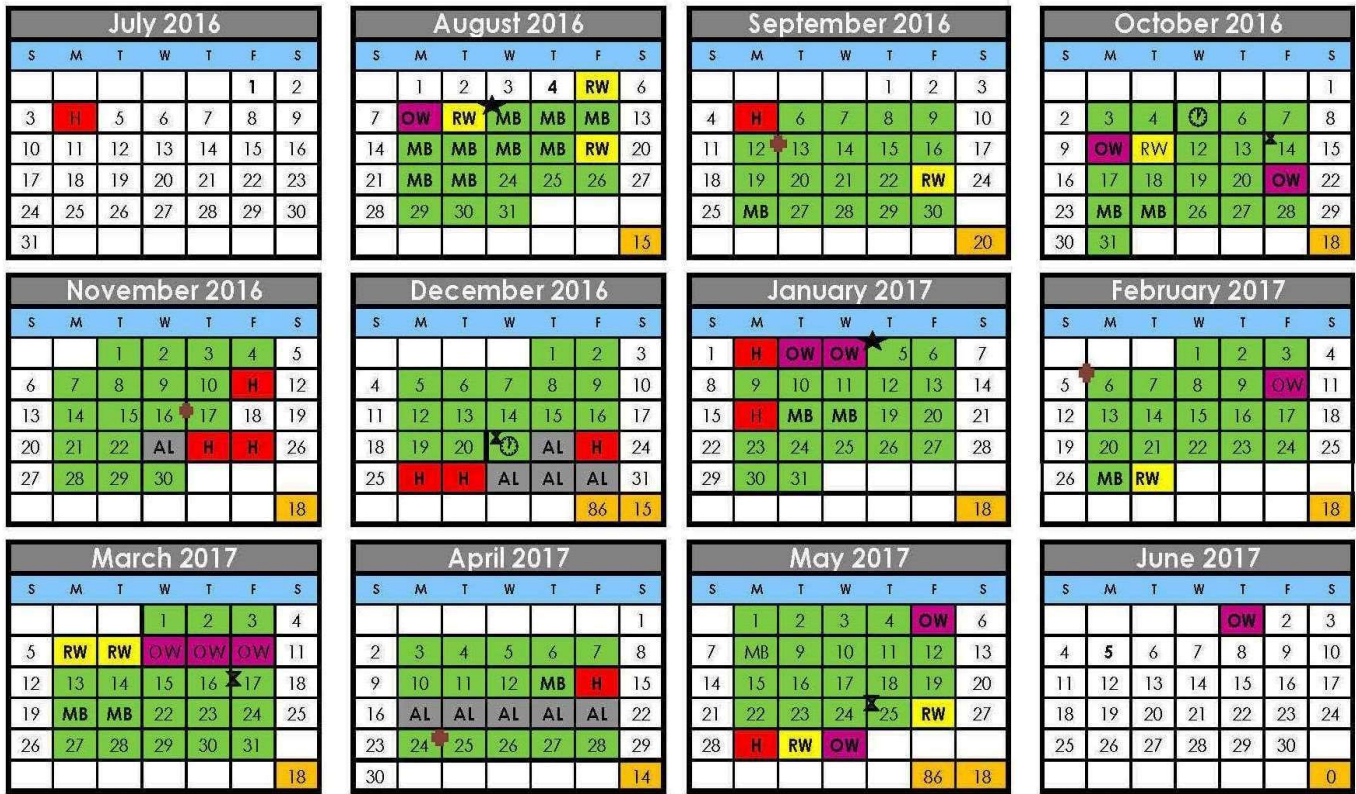

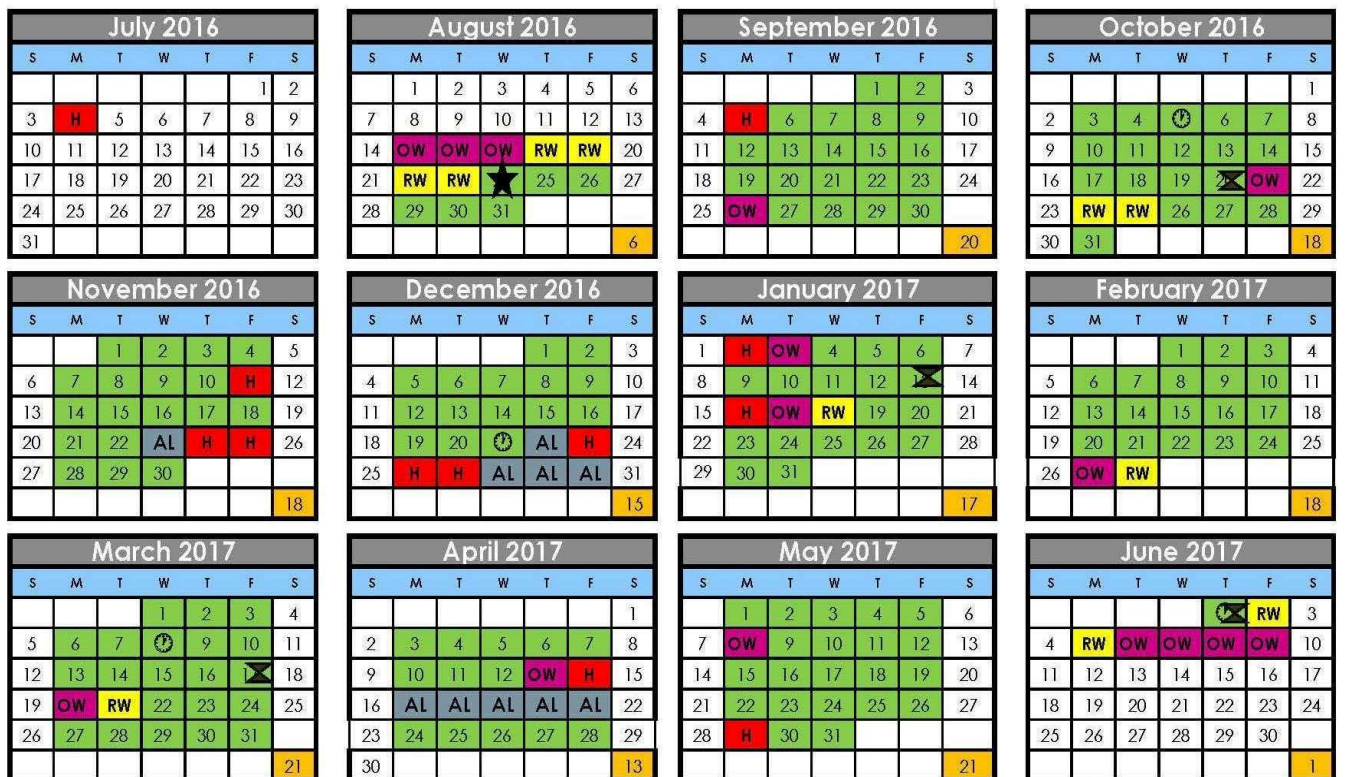

Economic Development

Yadkin County and the Yadkin Valley continue to grow as a tourism destination, driven by our wineries, Civil War Trail markers, Lake Hampton at Yadkin Memorial Park, Yadkin River, Quilt Trail, and the Yadkin Cultural Arts Center. One new winery, Sweet Home Carolina Vineyard and Winery, has joined the existing thirteen currently in Yadkin County. Domestic Tourism in Yadkin County generated an economic impact of \$35.07 million in 2014, an increase of 5.02% from 2013. In 2014, Yadkin County ranked 30 in travel impact among North Carolina's 100 counties. Travel generated a \$5.91 million in payroll in 2014, and state and local tax revenues from travel to Yadkin County amounted to \$2.66 million.



Indera Mills recently completed a 50,000 square foot expansion of their warehousing and distribution facility located in Yadkinville. Indera Mills produces winter weight undergarments for men, women and youth as well as "Coldwoof!" pet thermals. Indera Mills is headquartered in Yadkinville, and is the largest producer of thermal underwear in the United States.



Lydall Thermal Acoustical is expanding their Hamptonville location with the addition of new facilities and equipment. The Economic Development Partnership received a grant from the Golden Leaf Foundation to assist in the purchase of a scrap metal baler to be used as part of the expansion.

NCTI

North Carolina Tobacco International began operations this year in East Bend, initially with four production lines. Production is expected to increase and NCTI plans to have a workforce of 75 by next year when they reach full production.



PVH continues to add employees at the Jonesville Distribution Center and is now a three-shift operation, home to over 800 full time associates. Highway infrastructure improvements and the addition of the traffic circle at NC 67 and PVH Quality Way has helped tremendously with traffic flow exiting the facility. PVH owns Calvin Klein, Tommy Hilfiger, Van Heusen, Izod, Arrow, Speedo, Warner's and Olga brands.
