

## 4th AMENDMENT OF SOLID WASTE COLLECTION SERVICES AGREEMENT

**Date of Agreement: September 6, 2016**

Yadkin County is requesting to add one front load dumpster for Municipal Solid Waste (MSW) collection. Per Section 9 of the Solid Waste Collection Services contract between Yadkin County and Republic Services of North Carolina, LLC, dated July 14, 2014, "This agreement may be modified only by a writing signed by both parties."

This amendment agreement serves as written notice that Yadkin County and Republic Services of North Carolina, LLC, agree to add the following location to the Agreement as an addition to Exhibit A, MSW Collection Schedule County Owned Containers (see attachment), and the new location will be added to the collection route and invoice.




