

## **AMENDMENT II** **Subsidy Memorandum of Understanding**

This agreement amends the MOU bearing the effective date of July 1, 2016 between the Smart Start of Yadkin County, Inc. (the "Local Partnership"), and Yadkin County Human Services (the "LPA") (referred to collectively as the "Parties"). This Amendment is hereby effective on February 15, 2017.

As provided for under the terms of this MOU, the Local Partnership and the LPA agree to amend the following provisions:

1. Reference Section II. "Partnership agrees to:" The amount of funding given for TANF/CCDF eligible children increased by \$944 from \$145,000 to \$145,944.

All other terms and conditions as set forth in the original MOU document shall remain in effect for the duration of this MOU.
