

County Administration

The County Commissioners, as the governing body, are responsible for developing policies, levying taxes, adopting ordinances, appointing committees and appointing the County Attorney, County Manager, Tax Administrator and Clerk to the Board.

The County Manager is responsible for the day-to-day operations of the government. The Manager has a variety of responsibilities, including implementing and enforcing policies and goals adopted by the Board of Commissioners, administration of County departments and the preparation of the recommended annual budget.

FY20 started off great with many new projects, including the planned movement of the Human Services Agency's Medical Clinic (Health Department) from the Yadkin Medical Campus to Maple Street to shared space with Hands of Hope and the groundbreaking for the new Sheriff's Administration Building on Cherry Street. However, nobody saw COVID-19 coming our way and the impact it would have on our lives and economy.

As we also look toward FY21, COVID-19 continues to be with us and the final impact is still unknown.

The *County Commissioners*, as the governing body, are responsible for developing policies, levying taxes, adopting ordinances, appointing committees and appointing the County Attorney, County Manager, Tax Administrator and Clerk to the Board.

Administration – Human Resources

Human Resources is involved with all phases of the employment cycle. Significant work includes new-hire orientations, benefits administration, leave coordination, assisting with policy interpretation, reviewing all personnel actions, background checks, maintaining personnel records, and assisting with the retirement process.

During FY20 there were **92 new hires**, including **38 full-time employees, 26 part-time employees**, and **28 seasonal employees**. Employee turnover of full-time staff was **9.05% for FY20**.

There were **two lost-time injuries** recorded during the fiscal year, and **eight recordable injuries** that did not require time away from work. We value the safety of employees and continue striving to provide a safe workplace.

Agricultural & Educational Building / Banquet Hall

The **Yadkin County Agricultural & Educational Building / Banquet Hall** has been open for over four years at 2051 Agricultural Way on the campus of Surry Community College's Yadkin Center, Hwy 601.

This facility offers additional classrooms and labs on the lower level of Surry Community College. The upper level provides office space for NC Cooperative Extension, Soil & Water Conservation District

(NRCS), USDA Farm Services Agency and NC Forest Service. The upper level also offers two banquet rooms that may be combined into one larger room and a commercial kitchen that are all available for rent for private or public functions.

In 2017, Yadkin County launched the **Yadkin County Business Development Kitchen (YCBDK)**, located in the Yadkin County Agricultural & Educational Building. This is a shared commercial kitchen that is inspected and licensed by the County's Environmental Health department. This space can be utilized by individuals or groups who want to start a food-related business without investing upfront capital.

The **Banquet Hall** is a perfect location for meetings, parties and weddings. It offers one larger or one smaller banquet room, or combine both rooms into one large banquet hall. Rental includes a podium, audio/visual equipment, wireless microphones and a sound system available for use. We have 72 inch round and oblong tables and chairs available at no additional cost.

The **YCBDK** is also available for rent. Kitchen rental includes preparation areas, refrigerator, dishwasher, freezer, coolers, stove ovens, coffee makers, ice maker, china and utensils.

In FY20

- **Gray water dumping** began March 2020 with new revenue of \$1,420. We currently have eight food trucks on contract for their gray water disposal.
- Environmental Health licensed **two food trucks that rent the YCBDK**. We also have contracts with six other food-related vendors.
- Rental of the Banquet Hall and YCBDK totalled **530 hours**.
- The Banquet Hall **was rented 79** times, with **15 events** cancelled due to COVID-19.
- Banquet Hall rental. \$ 32,696.80
- YCBDK rental \$ 4,116.60
- Gray water disposal. \$ 1,420.00
- Total revenue before refunds \$ 38,233.40
- Deposits refunded \$ 900.00
- Refunds for canceled events \$ 1,873.88
- Revenue loss/cancellations. \$ 8,211.75
- **Total revenue \$ 27,247.77**
- Events **totaling \$ 8,023.43** were postponed by renters and moved to FY21.
- Six receptions were not able to take place due to COVID-19. Each would have generated \$ 1,600.00 for a **total \$ 9,600.00**.



Animal Shelter

The **Animal Shelter** had **754 animals that were adopted**, returned to owner or pulled by a partnering rescue in FY20.

We spayed/neutered **50 animals** through our Spay/Neuter Program.

We had **26 people who volunteered** at the Shelter for a total of 1,003 hours doing things such as walking dogs, socializing animals, assisting with events, as well as dishes, laundry and many other things. Our volunteer program was placed on hold for several months due to COVID-19.

We had 108 animals that were in foster care for FY20.

Board of Elections

The **Board of Elections** holds elections every year. Federal, State and County elections are held in the even-numbered years and Municipal elections are held in the odd-numbered years.

The Board of Elections is responsible for registering voters and maintaining the registration database, filing candidates, preparing ballots, testing voting machines, preparing for and holding the One Stop Early voting and staying up-to-date on required laws and processes. They also train precinct officials, produce in-house voter IDs, accept and process absentee requests from Civilian and Military voters and produce Election Day results.

After permits are issued, follow-up inspections are made as required to insure compliance with local ordinances and State Codes plus Environmental Health rules. Issues that are found not in compliance are noted and staff works with permit holders to correct.

Yadkin County Central Permitting strives to stay up-to-date with technology to speed up the permitting process, but still maintains the *hands-on approach* to customer service to assist citizens through the process.



Yadkin County Central Permitting is comprised of Planning, Environmental Health, Permitting, and Building Inspections. All permits for new construction, remodeling, and change of occupancy for the County as well as the Towns within the County are issued from this office. Types of permits include: Building, Electrical, Mechanical, Plumbing, Insulation, Pools, Sprinkler Systems, Fire Prevention,

Day Care, Foster Homes, Zoning, Septic Systems, Wells, Food and Lodging.

After permits are issued, follow-up inspections are made as required to insure compliance with local ordinances and State Codes plus Environmental Health rules. Issues that are found not in compliance are noted and staff works with permit holders to correct.

Frequently Asked Questions

Do I have to get a permit?

You need to get a permit when you build a structure larger than 12 ft.

Do I need a permit for a swimming pool?

Yes, you need a permit for a swimming pool.

Why do I need a zoning permit?

To insure compliance with the zoning ordinance or insure the use is permitted in that specific zoning category.

Do I need a permit for the portable Amish-Style buildings?

Yes.

What does ETJ stand for?

Extra territorial jurisdiction — referring to the mile outside the town limits where the town's zoning ordinance applies.

What are your hours?

We are open Monday – Friday from 8 a.m. to 5 p.m. No permits are issued after 4:30pm.

Economic Development / Tourism Development

While 2020 has presented a lot of challenges, several manufacturing industries in Yadkin County were able to quickly pivot to produce products needed to deal with the COVID-19 pandemic.

Indera Mills brought out some 50+ year old sewing machines and began producing multi-layer cloth masks. After the initial rush, Indera was able to produce custom screen-printed masks as well. As a vaccine came into view and the demand for masks was met, Indera pivoted back to manufacturing thermal underwear and base garments. President John Willingham and staff donated 33,500 masks to 24 non-profit organizations in Yadkin and Forsyth Counties.

Hibco Plastics quickly rotated to purpose foam for masks as well as a foam headband to help with comfort and fit for face shields.

Windsor Run Distillery transitioned to manufacturing hand sanitizer packaged in two different sizes. Windsor Run was able to distill an alcohol anti-septic 80% topical solution to use as hand sanitizer when soap and water was not available.

Lydall Thermal Acoustical Solutions, quickly converted their automotive cut and sew operation to produce protective masks, primarily for Lydall employees. The BriCo masks, named for their developers, uses meltblown filtration media

manufactured by Lydall's Performance Materials business which supplies similar material to medical masks producers. Lydall President Joe Abbruzzi and team members contributed a number of masks to Yadkin County first responders, law enforcement officers, and Novant Medical Associates in Yadkinville.



Yadkin County Tourism Development Authority

Yadkin County Tourism Development Authority received a grant to promote visitation to Yadkin County. A new video was produced along with new printed promotion materials and a billboard campaign. We also received a supply of "Count on Me NC" imprinted face masks that were distributed to Yadkin County restaurants. The video is available at VisitYadkin.com.

Emergency Services

Yadkin County Emergency Services is the central hub for the coordination and delivery of services for the majority of emergency situations that arise in our county. We are responsible for the citizens that live in our county and those that work here and pass through our borders. There are four divisions that make up Yadkin County Emergency Services.

The following will introduce you to these divisions and the services they provide.

Emergency Medical Services (EMS)

EMS provides the county with 24-hour advanced life support coverage in the form of treatment and transport to area hospitals. This service aids the sick and injured to be able to bring cutting-edge advanced care to the patient and maintain this level of care while they are being transported to a definitive care facility. Our Paramedics are trained to the most advanced level allowed by the NC Office of Emergency Medical Services. The staff is involved in constant continuing education, delivered by our own State-approved Advanced EMS Education Institution. Our County Commissioners have provided us with the most advanced equipment on the market. EMS falls under the direction of our Medical Director, who is a Board Certified Emergency Physician.

At the time of this report we were functioning during a worldwide pandemic which greatly changed the way we operate. Due to the COVID-19 virus, we have had to rely heavily on personal protective equipment (PPE) and new methods of cleaning and disinfecting to protect our staff and the public that we serve.

In the beginning, the procurement of this protective equipment was difficult to say the least, but with the assistance of NC Emergency Management and FEMA we were able to continue to maintain appropriate levels of PPE. Our calls for service did drop some during this report period due to the fear of the virus and going to medical facilities. We did, however, **respond to 5,451 calls for assistance**.

This division is under the direct supervision of Chris Bolden, the EMS Operation Manager.

Fire Marshal's Office

The second most well-known and visible division is our **Fire Marshal's Office**, led by Fire Marshal Ricky Leonard with a part-time staff of four Fire Inspectors. The Fire Marshal is on-call 24 hours a day, 7 days a week to aid the Fire Chiefs of our county in the determination of origin and cause of fires. He holds three distinct credentials in this field. They are: NC Certified Fire Investigator, NC Fire Investigator Technician, and International Fire Investigator Technician. He was called upon to complete 36 investigations this year.

The Fire Marshal is in charge of all Fire Safety Inspections. All businesses are required to have a fire safety inspection to be in compliance with fire code and are on a schedule determined by the type of business. Our Fire Marshal is credentialed as a Level III Fire Safety Inspector and leads the team of part-time Inspectors to complete the task of fire safety inspections to ensure the places that do business in Yadkin County are safe for staff and patrons. The pandemic has hampered the inspections department some this report year. They were able to complete 317 Fire Safety Inspections.

One of the most important duties of the Fire Marshal's Office is Fire Life Safety Education (FLSE). The Fire Marshal works independently and in conjunction with our County Fire Departments

to educate the public on fire safety issues. This education is to help identify life safety problems with the general public and in homes to eliminate them before they may put someone's life at risk. Our target populations are the elderly and children. Last year there were 11 Fire Life Safety Education Events.

The Fire Marshal assisted the Office of the State Fire Marshal in the grading of two of our Fire Departments this year. Both departments, Courtney and Buck Shoals, were successful in lowering their ISO grade, meaning there were significant savings in homeowner's insurance premiums in those districts.

Emergency Management

Emergency Management is a division of Emergency Services that works primarily in the background creating and maintaining emergency and disaster planning. Examples of these plans include evacuation plans, sheltering plans, vital supply plans, and points of distribution. In the event of a disastrous situation, this division comes to the forefront and works in two capacities. First, Emergency Management will open the Emergency Operations Center (EOC) as the nerve center for the event and establish command. Secondly, they will serve as a liaison between the County and State/Federal resources of assistance.


Another key element of Emergency Management is to work with the Board of Commissioners, County Manager and the County Attorney in establishing a Declaration of a State of Emergency. During this report period Yadkin County has had two State of

Emergency Declarations, one for winter storms and flooding in February and one for COVID-19. This is crucial in granting the authority to navigate disasters or large scale emergency situations. We are also responsible for maintaining Yadkin County's Storm-Ready designation.

On a daily basis Emergency Management will respond to and investigate any release of hazardous materials. Our duty is to insure that appropriate measures are taken to remove them and the proper authorities are notified.

Health Preparedness

The **Health Preparedness** division works with our Human Services Agency to monitor and respond to any out-of-the-ordinary or large scale health events. The hard work of this division has been crucial in the COVID-19 response and the ability to have the PPE and other equipment necessary to combat this pandemic. They prepare plans to be followed in the event of any illness outbreak and are dedicated to tracking down the cause of the illness in order to quarantine and limit the spread. They work closely with the NC Health Preparedness division and the Centers for Disease Control (CDC). In the event that mass inoculations are needed, our Health Preparedness Team will respond and set up Points of Distribution (PODs) to aid in getting much needed medication to our citizens.



Finance

Revenues

The County receives money from a variety of sources to provide services to citizens.

Local Governments rely on tax revenues for providing services to citizens. In Yadkin County, 82.3% of the total operating revenue comes from taxes. The two primary taxes that generate revenue are property tax and sales tax.

- **Property tax** is the County's largest single source of revenue; this accounted for \$20.5 million, or 54.51%, of the governmental revenue. The current property tax rate is \$0.66 per \$100, making Yadkin County the 42nd lowest of all 100 counties.
- **Sales tax (and other taxes)** accounted for 23.15%, or \$8.7 million, of revenue. These taxes increased by around 9% from the year prior.

Expenses

The money that is expended to provide services.

The County incurs a number of expenses to provide quality services to our citizens. Two of the County's largest expenses are Education and Public Safety. Education expense makes up 25% of the County's expenses and Public Safety expense is 31%.

- **Construction on the new Sheriff's Administrative** building started and should be complete in FY21.





The FY20 adopted budget for Yadkin County totaled \$37,056,495. The budget was an increase of \$449,214 from the FY19 adopted budget.

In FY20, the actual expenditures were \$1,285,974 less than the adopted budget of \$37,056,495. This decrease was largely due to the COVID-19 Pandemic that started in March of 2020.

The Finance Department continues to implement and abide by North Carolina General State Statutes. These requirements put in place internal controls, the pre-audit of expenditures, as well as other processes that the Finance staff must follow.

Human Services Agency

The mission of the **Yadkin County Human Services Agency** is to protect and improve the health and quality of life of the citizens of Yadkin County. This is accomplished through the strengthening of families, promotion of self-sufficiency, eliminating poverty, assuring and maintaining healthy environments, education of the people, providing preventative health services and enforcing state rules and regulations.

The Human Services Agency of Yadkin County is comprised of the Public Health Department and the Social Services Department. The Yadkin County Board of Commissioners consolidated these two County departments in 2013. The governing boards for the Public Health and Social Services divisions of the Agency are the Board of Commissioners. This agency is one of the larger County departments, with 77 employees and an annual budget of over eight million dollars. Much of this budget is state and federal dollars.

Social Services Department

The **Social Services Department** administers many federal and state entitlement programs. These include Food and Nutrition Services, Family and Children's Medicaid, Adult Medicaid, WorkFirst, Subsidized Child Care, the Low Income Energy Assistant Program (LIEAP), and the Crisis Intervention Program (CIP). Service programs include Child and Adult Protective Services, Foster Care and Adoption Services, Foster Home Recruitment, Training and Licensing, Adult Guardianship Services, Adult Home Specialist Services, Community Alternatives to Placement for Disabled Adults (CAP-DA) Services, Level I In-Home Aide Services, and Child Support Services. All Social Services programs and services can be accessed at our main building located at **217 E. Willow Street, Yadkinville, NC**.

Social Services **highlights for FY20** include bringing the **Level I In-Home Aide** program back into the department. This program provides services to elderly and disabled adults that need assistance in their homes with IADL (Instrumental Activity of Daily Living) tasks. These tasks typically include assistance with grocery shopping, essential errands such as picking up medications, mail and bill management, housekeeping tasks, and meal preparation. The

ultimate goal of this program is to keep people in their homes safely as long as possible. This program is available to anyone who needs this level of care regardless of income. We are **currently serving 17 residents in this program with a waitlist of 21**.

Public Health Department

The **Public Health Department** is comprised of the Yadkin County Medical Clinic, WIC (Women/Infants/Children) and Environmental Health. The Medical Clinic provides the following state public health programs to eligible County residents: Maternal Health, Child Health (including well-child visits and primary care), Communicable Disease/STDs, Family Planning and Immunizations.

In January of 2020, the Medical Clinic moved into a new facility located at 320 West Maple Street, Suite B, Yadkinville, NC. This space is collocated with Hands of Hope Medical Clinic, which enhances partnership between the two agencies.

In January of 2020, both agencies received "The Chairman's Award" at the annual Yadkin County Chamber of Commerce banquet. The Medical Clinic also includes a Health Education program that is grant-funded. This program offers child care consultation services to licensed Yadkin County childcare providers as well as implementation of the Healthy Communities program. Public Health

highlights for FY20 include the County Health Educator assisting the Town of Yadkinville with applying for a grant to receive bike helmets through the NCDOT. After the grant was awarded, the Town purchased 75 bike helmets for distribution. We also developed and distributed an Opioid Resource Guide to assist residents with connecting to support and services related to substance abuse. The 2020 Community Health Assessment was also completed and submitted to NCDHHS in March of 2020.

Women/Infants/Children (WIC)

WIC (Women/Infants/Children) is a supplemental nutrition program for women, infants and children that is funded by the United States Department of Agriculture (USDA). Residents can apply for WIC at the County Human Resources Building located at **217 E. Willow St., Yadkinville, NC**.

In December of 2019, the WIC program began distributing **electronic learning tablets called ApSeeds**. The tablets have educational games and programs pre-programmed onto them but do not connect to the internet. The goal is to better prepare children for Kindergarten through improved literacy skills. Yadkin County residents age 0-4 who receive Medicaid, food stamps or WIC are eligible for the tablet at no charge.

In February 2020, the WIC unit began an innovative collaboration with the Yadkin County Cooperative Extension to implement the **WIC garden**. This project entailed eight container garden boxes

installed outside of the Human Services Agency. With increasing sustainability as the goal, WIC clients and community members will have the ability to utilize the garden boxes to learn more about the benefits of home gardening, such as food preservation, decreased food insecurity, and increased access to healthy, nutritious foods year round.

Environmental Health

Environmental Health is a very important division of the Human Services Agency. There are two main program areas within Environmental Health: **Food, Lodging and Institution (FLI)** and the **On-Site Water Protection (OSWP)** section. The FLI section is responsible for the regulations, permitting and inspection of all of the food service facilities in the County, which includes all school cafeterias and nursing home food services. Additionally, we inspect all lodging facilities, childcare centers, school buildings, nursing homes, residential care facilities, local confinements, tattoo parlors and public swimming pools. **The average score across all food services facilities was 95 for fiscal year ending June 30, 2020.**

The On-Site Water Protection section is responsible for protecting the environment and public health by regulating septic systems and private water wells. Environmental Health is housed in the Planning and Permit Building located at **213 E. Elm Street, Yadkinville, NC**. Permits are issued at this location Monday through Friday from **8 a.m. to 4:30 p.m.**



Information Technology

The **Information Technology** Department is responsible for supplying and maintaining the County's information system and other digital needs. This system is comprised of computers, servers, software, network wiring, switches, wireless, firewall, VPN, security video and many network security-related items that no one ever sees. We maintain **over 3,400 actual devices**.

While Yadkin County may not be the largest county in the state, we have the exact same types of data that even the largest counties have, just a smaller amount. This means we have to take the same security precautions as the larger counties. It requires the same caliber of equipment to protect our smaller amount of data as it does for the larger amounts.

The pandemic affected us late in the 3rd quarter, which had us ramp up telework efforts as well as decontamination of equipment.

In today's world we must **diligently monitor the network for attacks** of any type and be ready to respond accordingly to intercept and stop the attack.

- Our **firewall** must stay patched to keep up with the ever-changing types of attacks.
- We are a member of the MS-ISAC (Multi-State Information Sharing and Analysis Center), which is a round-the-clock **cyber threat monitoring** and mitigation center for state and local governments.
- During the last year there were **no recoveries needed** of County information due to Malware and Ransomware.

Yadkin County is also PCI-compliant, meaning we meet the security standards designed to ensure that the information we receive with regards to credit card transmittals is maintained in a secure environment.

Our GIS website is now hosted on-site by the IT Department and maintained by the GIS Department. This allows for quicker updates on the website for new and updated addresses.

We are here to support all County departments with their IT resources. Whether it be with equipment and software or research and education, we strive to meet the department's needs efficiently and cost effectively.

- **96 mobile phone** users
- 19 County locations containing **security cameras**
- **2,600 help tickets** were processed
- Maintained the **Mobile Command Center**
- Replaced core switches to **achieve 20GB connection**
- Maintained network infrastructure to **20GB fiber** between buildings
- Maintained map updates for **911** and **field Public Safety** units
- Maintained the **911 primary and backup** operations center



Parks & Recreation

Yadkin County **Parks & Recreation** operates and manages **seven different areas** for the public to enjoy throughout the year. These include Yadkin Memorial Park at Lake Hampton, Yadkin County Park, Styers Mill Park, Richmond Hill, Shores River Access, Donnaha River Access and Huntsville River Access. The Parks & Rec department also serves as the county landscape maintenance for all county-owned property. This encompasses **29 sites and over 900 acres**. Below is an overview of all that Yadkin County Parks & Rec has to offer and updates on current projects.

Yadkin Memorial Park

Yadkin Memorial Park sits on Lake Hampton and is the County's newest park. It opened in November 2014 and has steadily become a popular spot for kayakers, walkers, bird watchers and overall nature lovers. Fishermen also enjoy the quiet lake setting as they come to catch a variety of stocked fish including crappie, bass and catfish. As a convenient "one stop shop", the office at Lake Hampton carries a variety of bait, ice, snacks and drinks. The employees are also registered to sell hunting/fishing licenses, as well as register your boat. While personal kayaks, trolling motor powered boats, paddle boats and stand up paddle boards are all welcome on Lake Hampton, gas-powered boats are not permitted. If you do not have access to a personal boat, the County does provide a variety of kayaks and jon boats that can be rented out by the hour or for the day.

This year, Yadkin Memorial Park again offered an opportunity for duck hunting through a lottery system. By closing on specific days throughout the fall and winter, Lake Hampton provided the lottery winners with a great location to hunt.

The other amenities at Lake Hampton include two picnic pavilions (which can be rented for events), a paved walking trail, a playground with swings, picnic tables, charcoal grills, two fishing piers and a boat launch. The facilities also include a universally accessible kayak launch. With step-by-step instructions, this kayak launch allows almost anyone to enjoy a day on the water, regardless of physical limitations.

The walking trails through the woods on the west side of Lake Hampton are complete and new signs have been placed to help guide you through the scenic woods and close to Lake Hampton. These trails are approximately 1.75 miles long. The informational signs were provided by the Carolina Bird Club grant.

Yadkin County Park

Yadkin County Park is located near the YMCA and is home to an outdoor pool (seasonally), a large pavilion, a walking/jogging trail, a nature trail, an amphitheater, a fishing pier, a large playground, three baseball/softball fields, six soccer fields, a disc golf course, an outdoor volleyball court, a veterans memorial and a dog park for large and small dogs.

The park is conveniently open from 8 a.m.-10 p.m. all year. The shelter facility can provide the perfect space for a birthday party or celebration with the recently renovated indoor room attached that includes bathrooms and a kitchen.

Richmond Hill

The picnic pavilions and park area near Richmond Hill is maintained by the Parks & Rec department and is located within the 30-acre Richmond Hill Law School and Nature Park. Donnaha access was recently renovated with the addition of a new boat launch for kayaks and a parking area. This work was completed by The North Carolina Wildlife Resources Commission.



Parks & Recreation Current Projects

• **PARTF (Parks & Recreation Trust Fund)** grant phase two for Memorial Park has been completed. The new amenities provided by the PARTF grant are primitive camping sites, a restroom and bath house, a dog park and an additional shelter on the west end of Lake Hampton. On the east side of the lake a new access road off of Ireland Road, a new parking lot, the new George Sappenfield Disc Golf Course at Yadkin Memorial Park East, and trail extensions off of the RTP grant trail.

- **NC Connect Grant for Memorial Park** has been completed. The addition of new playground equipment adjacent to the current playground includes spinner play panels and rubberized surfacing throughout the new area.
- **NC Connect Grant for County Park** has been completed. The initial installation of the equipment was completed in 2017 at Daniel's Playground, but with additional funds left in the grant we added shade to the playground. A large 54' x 34' structure allows for much needed shade during the very hot summer months.
- **A new shelter is being built at the walking track at the Yadkin County Park.** This shelter will be named the **Phil Martin Shelter**. Phil has worked for Parks & Rec since March 1984 with 21 years of full-time work and 15 years (*and counting*) of part-time work. We are very excited to have this shelter named after Phil.
- **The nature trail at the Yadkin County Park will be getting a renovation** to the trail and trailhead. The trail will also be named the **Oz Prim Nature Trail**. Oz is a long-time park patron and supporter. We are honored to have this trail named after him.
- The trail that spans from **Memorial Park to Memorial Park east will also be renamed the Ashley / Ladd Trail**. These two families were major land owners of the lake property before the lake was constructed. We are honored to name this trail after these two great families.

Public Buildings

The **Public Buildings** Department is responsible for the overall maintenance of all public buildings owned by Yadkin County. Currently the County owns **approximately 50 buildings**, making the department responsible for the maintenance of approximately **233,000 square feet** of floor space.

During FY20, the Public Buildings Department processed **635 work orders**. The department has **four automobiles** and **five pool vehicles** that are maintained with Yadkin County's vehicle fleet. The department is also responsible for cleaning **eight buildings** within the County and maintaining approximately **157 HVAC units** for the County buildings.

In FY20, the Public Buildings Department remodeled a building located at 320 Maple Street for the new Medical Clinic, Hands of Hope facility.

We also installed new HVAC units for the Courthouse Magistrate's Office, the lobby of the Social Services Department and the Probation building.

Register of Deeds

By law, the **Register of Deeds** serves as custodian and manager of **large volumes of public records for the County**. The Register of Deeds is legally charged with the integrity, completeness, accuracy and safekeeping of these public records. This amounts to approximately 5,000 documents and plats recorded and 275 marriage licenses issued each year. The documents recorded include Deeds, Deeds of Trust, Powers of Attorneys, Separation Agreements, Plats, Deed of Trust Cancellations, Military Discharges and various agreements. The office also records and issues certified copies of birth, death, and marriage records, issues notary public oaths and maintains a listing of all notaries who reside in the County. **The annual revenue collected is approximately \$340,000 - \$390,000 for these various recordings and services.**

We use the most current technology to ensure easy access and retrieval of all our records and provide a courteous and professional environment. In October 2015, e-recording was implemented which allows out of town attorneys and lending institutions to electronically file documents in a more efficient and timely manner. In April 2017, Electronic Birth Registration System (EBRS), a program administered through the Department of NC Vital Records, was implemented which allows customers who were born in 1971 and later to acquire a certified birth certificate if they were born in another North Carolina county. In May 2017, a Veterans ID card program was started to encourage more veterans to record their discharges in the Register of Deeds office. This ID card is proof that the veteran has a

discharge recorded and is eligible for any discount a business may offer. Get Certificate Now, an online vital records application, has been implemented which allows a customer to order vital records and pay for them online.

A fraud detection notification service called "Property Notification" was implemented in 2020 which sends an email notification when a document is recorded in the Register of Deeds office that matches someone's name who has signed up for the service. There is no charge for this service.

Sheriff's Office

Another year has passed, and what a year it has been! Last year started out, as the prior year, with normal crime rates and calls for service here in the Yadkin County **Sheriff's Office**. As 2020 arrived, things began to change around the country and here in Yadkin County as well. Protests continued to increase with many becoming violent with assaults on law enforcement and destruction of property. Calls for police reform and defunding of law enforcement agencies were heard around the country. Concerns about the upcoming election and how it would affect our lives in the future would often turn violent. **COVID-19, Coronavirus, and pandemic** became words used daily as infection rates and deaths increased. Executive Orders, business closures, limitations on gatherings, social-distancing, masks and quarantine where all topics of discussion daily. Locally, heavy rains, flooding, storm damage, and power outages affected many of us as we wondered what was next. Certainly, all of our lives have been affected in some way in 2020.

As you review the charts and statistics from last year, you will see the Sheriff's Office and staff have been very busy. Our Communications Center **received and processed 49,670** calls for service. The Sheriff's Office staff processed and issued **648 handgun purchase permits** and **820 concealed carry permits** this year. The graphs will show a significant

increase in arrests for robbery, assaults, burglary, and drug offenses. Even with this increase, the in-custody arrests and persons detained in our Detention Center decreased. This was due to reductions in inmate populations in response to COVID-19. Due to many people being out of work, school closings, quarantines, and the resulting stress, the COVID-19 pandemic significantly increased our domestic violence calls.








Soil & Water

The Yadkin Soil & Water Conservation District operates under the guidance of the Yadkin Soil & Water Conservation District Board. The District Office works with landowners to provide technical assistance to improve water quality and minimize soil erosion. The Soil & Water District also operates the 15 flood control structures (dams) within Yadkin County including the Hood/Chamberlain (5D) Reservoir.

In 2020, there were 48 conservation plans written covering 3,540 acres for practices that support the Farm Bill and other federal and state programs. Practices in these plans include crop-based rotations, animal waste management, livestock exclusions, grassed waterways, field borders and other conservation practices. We also offer two, 10ft wide John Deere drills and one, 7ft wide Haybuster drill available for rent through our office.

During 2020 these drills were utilized by 39 farmers on 1,100 acres of cropland.

The Soil & Water office is located at **2051 Agriculture Way, Yadkinville, NC.**

Solid Waste & Recycling

The Yadkin County Solid Waste & Recycling

Department operates seven convenience sites and one Transfer Station within the County. Our convenience sites are strategically located across the County to serve almost 13,000 unincorporated households. Convenience sites accept bagged household trash and single-stream recyclables only. For all other

materials not accepted at the convenience sites, the Transfer Station at the Yadkin County Solid Waste Facility is available to all residents and businesses. The Solid Waste Facility accepts bagged trash, recyclables, construction and demolition debris, yard waste, metal, tires, electronics, and motor oil.

Yadkin County Solid Waste Statistics

Last year, 34,545 tons of solid waste from Yadkin County was transferred to Foothills Environmental Landfill in Lenoir, NC. This is an **increase of 6,224 tons** of municipal solid waste from the previous year.

The volume of solid waste processed at the Yadkin County Transfer Station in FY20 is the most in recent memory.

Along with the increased volume of solid waste disposed, all convenience sites experienced significantly higher traffic than normal throughout the spring of 2020. Solid Waste staff continues to work diligently to ensure safe traffic flow through the sites.

To reduce potential wait times at sites, the Solid Waste Department recommends that individuals with significant amounts of household waste and recycling go to the Solid Waste Facility at 1149 Landfill Rd.

The *Solid Waste Facility* accepts bagged trash, recyclables, construction and demolition debris, yard waste, metal, tires, electronics, and motor oil.

Compactors at Solid Waste Sites

In the fall of 2019, compactors were installed at five of the solid waste convenience sites. The compactors have assisted in increasing the cleanliness and efficiency of the convenience sites. Staff is available to assist citizens with questions and working around the compactors. The compactors will be in operation while the sites are open for residents to dispose of household trash. County residents will also continue to have the option of bringing household waste to the **Yadkin County Solid Waste Facility located at 1149 Landfill Rd, Yadkinville NC 27055**.



Tax – Assessor & Collector

The **Yadkin County Tax Office** is comprised of both the Assessor's and Collector's Offices. The **Assessor's Office** is responsible for the listing, appraisal and assessment of all taxable property in Yadkin County and furnishing tax base figures to the County for budget purposes. The most recent revaluation occurred in 2017. The next county wide general reappraisal will be 2023. **The Collector's Office** is responsible for the collection of all property taxes due to Yadkin County as well as the towns of Boonville and East Bend.

The County continued to see modest growth over this past year. The FY20 total valuation of real and personal property was \$2,728,075,894; an increase of just over 1.5% from last year. Residential new construction and remodeling is still the major contributor of new construction. However, there seems to be an increase in the interest of solar farms in the County.

The County's tax rate remained at \$0.66 per \$100 valuation. The Collection's Department also made great gains to increase the collection rate of taxes to 97.70%.

The Tax Office has a contract with the NC Department of Transportation to operate the License Plate Agency (LPA) in Yadkin County. The LPA office processed over 75,000 transactions this past year and the total tax levy collected on motor vehicles for the County was \$2,390,051.

Yadkin County offers a 2% discount for early payment of ad valorem taxes when you pay your taxes during the month of August after receiving your tax bill.

In addition to the property tax, you are billed a fire service tax that is collected by the County to contract with each volunteer fire department to provide fire protection service in each fire district.

Taxpayers are also assessed a **Solid Waste Household fee** on all dwellings at an amount of \$60. The Solid Waste stickers are enclosed with your tax bills and expire every two years.

Statutory Requirements

The property tax in NC is governed by Subchapter 11 of Chapter 105 of the General Statutes of NC. Local Boards of Commissioners have very little discretion in property taxes due to these statutes (also known as the Machinery Act) being state law rather than

local ordinances. The Machinery Act guarantees all 100 NC Counties will administer the property tax laws under the same guidelines with a minimum of local discretion. The County Board of Commissioners has the responsibility of setting the County tax rate.

Veteran Services

The office of **Veteran Services** is here to assist Veterans and their families in any way we can. We can help file for medical benefits, compensation and pension benefits, and educational benefits. Our job is to guide and assist veterans through the complex web of forms and regulations that make up the US Department of Veterans' Affairs and the North Carolina Division of Military and Veterans' Affairs.

Along with these services, this office also helps veterans connect with other veterans and veteran organizations in the community. We assist veterans in obtaining counseling services, as well as putting them in contact with groups to help with any need that they may have. You have served your country, now we are here to serve you!

Since April of 2020, this office has served 483 veterans or family members through office visits, phone calls, emails, and home visits. For FY19, the VA reported 2,148 veterans in Yadkin County received VA benefits. These veterans received a combined \$11,544,000.00 in compensation or pension benefits, a total of \$578,000.00 paid for education or vocational rehabilitation, and a total of **\$8,942,000.00** paid for medical care for the veterans of Yadkin County.

Water & Sewer

The **Yadkin County Water & Sewer Department** maintains the Highway 21 waterline and the East Bend waterline. County staff respond to any issue and manage the daily operations and maintenance of both waterlines. The County owns a waterline and sewer line along US Hwy 601 that is leased to the Town of Yadkinville for operations and maintenance.

Yadkin County purchases water from the Town of Jonesville to operate the Highway 21 waterline. The waterline extends along Highway 21 from Jonesville south to Lydall (near the I-77 and US 421 intersection).

The East Bend Waterline Project is now complete. Yadkin County has agreements with the Town of East Bend and the Winston Salem/Forsyth County Utilities Commission. In these agreements, the County purchases water from the Winston Salem/Forsyth County Utilities Commission that is then resold to the Town of East Bend. The waterline runs along Taylor Rd, a portion of Old US Highway 421, and on Flint Rd to the Town of East Bend.

Yadkin County Water & Sewer employees work diligently to ensure the efficient operation and maintenance of the Highway 21 waterline and the East Bend waterline. In addition to the daily monitoring and maintenance, employees assist municipal water departments if requested, perform 811 utility locates across the County, and assist with Environmental Health permitting for residents and businesses when needed.

In the spring of 2020, Yadkin County was awarded a Merger Regionalization/Feasibility Grant by the North Carolina Department of Environmental Quality Division of Water Infrastructure. Funds from this grant will go towards a study of the financial stability and longevity of all the water systems in Yadkin County. While this project will take several months to complete, the final report and recommendations could have a lasting positive impact for future generations of Yadkin County residents.

Yadkin Center of Surry Community College

The **Yadkin Center of Surry Community College** (SCC) has been designated as a multi-campus center due to the growth in student enrollment, and now officials at SCC are awaiting funding from the Office of State Budget and Management.

The State Board of Community Colleges, the NC Association of Community College Presidents, and the NC Association of Community College Trustees has endorsed the request to the NC General Assembly to provide funding in the amount of \$ 579,413 for the approved multi-campus center. Final approval is contingent on the NC General Assembly appropriating additional multi-campus center funds to Surry Community College.

The Yadkin Center, 1001 College Drive, in Yadkinville, houses the **Yadkin Early College** and includes the Yadkin Valley Agriculture and Education Center and the G. Allen Mebane IV Industrial Training Center.

Student enrollment at The Yadkin Center reached the pivotal enrollment number of 300 Full-Time Equivalency (FTE) to earn multi-campus status, surpassing the minimal requirement by 19 percent. The academic year consisting of Summer 2019, Fall 2019 and Spring 2020 resulted in an FTE of 357 students, which means that all of the courses taught at the Yadkin Center produced the equivalent of 357 total full-time students, equating to over 183,000 unduplicated hours of instruction within a single year.

"We are proud of Surry Community College's success in Yadkin County," said Dr. David Shockley, SCC President. "We have worked hard through the years to establish the groundwork for this multi-campus status. I am thrilled to be a part of the team that reached this milestone. We owe a debt of gratitude to the leadership of Yadkin County Schools and the Yadkin County Government who have partnered with SCC in this

endeavor to bring high-quality, affordable and convenient college education to the citizens of Yadkin County."

In January 2020, the SCC Foundation received its largest gift from **Mr. Gilmer W. Hinson of Jonesville who gave \$1.427 million** to support SCC students and programming in Yadkin County. His gift was transformational, enabling continued growth and diversification of programming at the Yadkin Center. He first contributed to the construction of the G. Allen Mebane IV Industrial Training Center in 2016.

"Mr. Hinson's most kind generosity is very humbling and will serve as a catalyst for positive change in the lives of SCC students enrolled at the Yadkin Center. It is extremely rare for community colleges to receive a financial gift of this magnitude, for which we are very grateful. We will use this gift to promote higher education opportunities that will benefit the citizens of Yadkin County for many generations," said Dr. Shockley at the time of the announcement. "The support for Yadkin County students to obtain a college education has been overwhelming from public and private sectors."

The Yadkin County Commissioners approved the **Yadkin Guarantee** initiative in 2018 ensuring that recent Yadkin County high school graduates could attend the Yadkin Center with tuition and book expenses paid by Yadkin County for up to \$750 per student for each semester. The Yadkin Guarantee funds fill in the difference where scholarships and federal financial aid stops. The scholarship program has helped 117 students since its inception, and participation grows each year: 2018, 17 students awarded; 2019, 39 students awarded; and 2020, 61 students awarded.



Yadkin Center students can complete a two-year Associate in Arts college transfer degree that leads to a bachelor's degree at a four-year college or university. Students also have the opportunity to complete the bridge program for Licensed Practical Nursing – Associate Degree Nursing (LPN-ADN) at the Yadkin Center, as well as a degree, diploma and certificate in Mechatronics; a diploma and certificate in Welding; and a diploma and certificate in Computer-Integrated Machining.

The Yadkin Center provides high school juniors and seniors a way to earn college credits, tuition free, while still in a traditional high school. Students at Forbush High School and Starmount High School can attend classes at the Yadkin Center during their regular high school schedule. Students who attend homeschooled or private schools can participate in the **Career & College Promise** program as well.

A variety of other training opportunities are also offered at the Yadkin Center including: Nurse Aide, Electrical Systems, Truck Driver, Fire, EMS, Law Enforcement, Basic Skills, High School Equivalency, and English Language Acquisitions, formerly English as a Second Language (ESL). The Truck Driver Training range at the Yadkin Center is Professional Truck Driver Institute (PTDI) certified.

Customized training for small and large businesses is available at the Yadkin Center along with many locations throughout Yadkin County.



The Yadkin Center of Surry Community College (SCC) has been designated as a **multi-campus center** due to the growth in student enrollment, and now officials at SCC are awaiting funding from the Office of State Budget and Management.

Yadkin Center Timeline

2003 – The **Yadkin Center**, a 25,000 square-foot facility with a learning center, computer labs and classrooms opened.

2007 – Yadkin County Schools and SCC developed the **Yadkin Early College**, which is located at the Yadkin Center. During the 2019-2020 academic year, the Yadkin Early College had an enrollment of 231 students.

2016 – The **Yadkin County Agricultural & Educational Building**, a cooperative effort between the Yadkin County Commissioners and SCC, opened its doors. The 34,000 square-foot facility provides shared space for Yadkin County Government and SCC for classrooms, training space, offices and a 300-person banquet hall with a commercial kitchen. A ribbon cutting ceremony was held on June 1, 2016. That same year, SCC added the Associate in Arts college transfer degree and the Mechatronics degree as a part of programming at the Yadkin Center.

2018 – The **G. Allen Mebane IV Industrial Training Center**, a 12,450-square-foot facility opened to provide state-of-the-art labs and classroom space for Mechatronics, Computer-Integrated Machining, Welding, and Truck Driver Training. The facility has five traditional classrooms and two large labs. The additional space allowed SCC to offer certificates, diplomas and degrees in advanced manufacturing.

2019 – SCC's **Licensed Practical Nursing – Associate Degree Nursing** (LPN-ADN) bridge program is now headquartered at the Yadkin Center to offer more educational opportunities in the medical field for Yadkin County residents.

2020 – SCC reached **multi-campus center approval** and reached a Full-Time Equivalency (FTE) of 357 students at the Yadkin Center.
