COUNTY MANAGER'S REPORT

September 23, 2022

COVID

Currently, there are 325 reported active COVID cases.

Holcombe House

Andrew Mackie provided me with a formal request for the Board of County Commissioners to transfer ownership of the Hauser-Harding-Holcomb House to the Charles Bruce Davis Museum, Inc. so they can move it to their property on Van Buren Street. They are anticipating moving the house before the end of the calendar year. We will need to prepare a bill of sale or some type of agreement between the County and their group pertaining to expectations of what they can remove and how the property/land needs to be left. He did say to me that they may have to trim some of the branches on the southern magnolia tree to remove the house. Attached in Exhibit A is their written request.

Public Schools' Needs-Based Grant Applications

Dr. Martin and I were notified this week that none of our Needs-Based Grant applications were approved. We submitted 5 applications: plumbing & sewer line repairs at West Yadkin Elementary (\$472,000); plumbing at Courtney Elementary (\$391,000), Forbush High School E-Building Roof (\$300,000) and auxiliary gyms at each high school (\$3,016,406 each). Those are the total costs of the projects and the County would have provided 5% of the projects' total cost as a match. Exhibit B contains the letter we received.

Elm Street Properties

We met with the structural engineer to assess any potential damage to the Dinkins building when we remove the buildings adjacent to it. It appears that the Dinkins (Shore Holcombe) building was built in 1907 and the Community Services Building was built after that. The Community Services building also suffered from a fire when it was a movie theater and apparently didn't damage the Dinkins building. We also explored options for the elevator/sally port at the Courthouse.


Last night the Joint Board of Directors met at the Tulbert House, 216 N. Van Buren Street, Yadkinville, NC, and approved the following motion:

In the 2022-23 grant cycle, 72 districts submitted 164 applications for projects totaling more than \$2.4 billion in requests, illustrating the tremendous need for this critical program. However, the amount of funding available for grant awards was \$302 million, or 12.4% of total requests.
