COUNTY MANAGER'S REPORT

January 31, 2025

Charters of Freedom

Grading will begin February 10 for the construction of the Charters of Freedom. They will be located in the courtyard at the Courthouse on the corner of Hwy 601 (State Street) and Main Street. The Charters include the Declaration of Independence, U.S. Constitution, Bill of Rights and Civil Rights. There are opportunities for donations to keep the Charters advancing in other locations throughout the country. There will also be a pedestal for the Sanctity of Life Resolution adopted by the Board of Commissioners. This pedestal will be built on the existing concrete where the flagpole previously was. The cost for the additional pedestal is approximately \$13,000-\$14,000, however a group of citizens have stated they have raised some funds for this purpose.

FEMA

As of January 27, 2025, over \$63,000 has been awarded in Individual Assistance from FEMA to residents in Yadkin County. Twenty-six applicants have been eligible for housing assistance and/or other needs assistance. Over 10 households have checked into hotels through the TSA program. Exhibit A contains information about FEMA's response to Hurricane Helene in North Carolina.

Vacancy Report

There are 15 vacancies this week. Human Services has 6 vacancies, all in the Social Services Division. The Sheriff's Office has 3 positions vacant, Emergency Services has 3 vacancies, Animal Shelter has 1 vacancy as well as Finance and the Tax Assessor's Office. Twelve of these positions have been vacant over 30 days, with 6 of them being in Human Services. Six of these positions (3 in Human Services, 2 in Emergency Services and 1 in Tax) have been vacant over 100 days. Two of these 6 positions have been vacant over 225 days.

Mountain Valley Hospice

Mountain Valley Hospice has submitted their request to extend their Ambulance Franchise Agreement with the County. They applied for their Franchise several years ago to transport hospice patients to and from the SECU Hospice Home in Yadkinville.

Libraries

The Northwestern Regional Library System operates 4 library branches in Yadkin County (Boonville, East Bend, Jonesville and Yadkinville). Exhibit B contains a usage report for the branches during FY2023-2024.

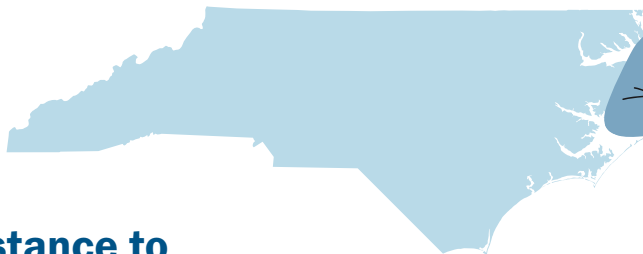

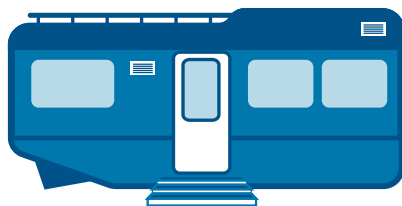

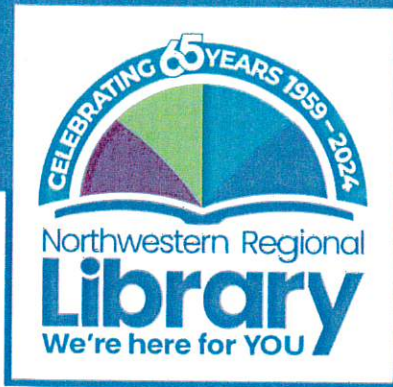

Yadkin County Branches FY 23-24

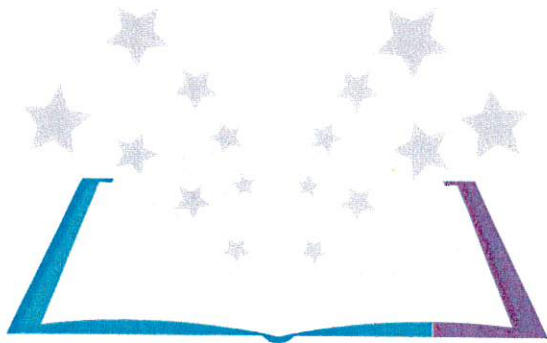

The NC Cardinal consortium offers 8.1 million items in the catalog for all patrons to borrow.

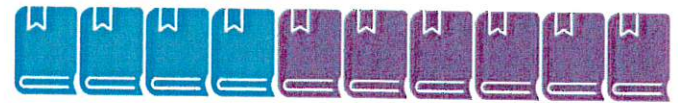
FY 23-24 circulation counts were 96,858
