COUNTY MANAGER'S REPORT

June 23, 2025

Vacancy Report

There are currently 12 vacancies throughout County departments. There are 3 vacancies in Human Services, 4 within the Sheriff's Office (2 Detention, 1 Deputy Detective, and 1 Communications), 3 in Emergency Services, one each in Central Permitting and Information Technology. Of these positions 6 have been vacant over 30 days and 2 have been vacant for over 100 days.

Fire Department Service Agreements

All Volunteer Fire Departments submitted Fire Department Service Agreements except for Boonville Community Volunteer Fire Department. Boonville Community Volunteer Fire Department informed us in writing and orally on Friday (06/27) afternoon that they would not execute the Fire Department Service Agreement. All Volunteer Fire Departments have been notified that they will need to provide automatic aid to the Boonville Fire District effective July 1, 2025, at 12:00 am. Boonville Community Volunteer Fire Department representatives have been notified that they can not provide fire services effective June 30, 2025, at 11:59 pm. Also, Boonville Fire Department representatives have been informed that they need to return all Yadkin County EMS equipment to Yadkin County Emergency Services no later than June 30, 2025, at 11:59 pm. They have been provided with the list of equipment that needs to be returned to Yadkin County EMS.

Yadkin County Annual Report

Department/Offices and organizational stakeholders have been notified about submitting their Annual Report no later than September 5th at 5:00 pm to the County Manager's Office. We will work with Wendy Horne on publishing the Annual Report.

Courthouse Space

The Tax Office, IT Department, and License Plate Agency have officially moved all their equipment out of their former offices. We are working with Juvenile Services on planning for them to move into the Tax Office space.

Highway 21 Booster Pump Station Generator and SCADA Project

Yadkin County has received a grant from NC DEQ in the amount of \$61,900, for the generator and SCADA at the HWY 21 booster pump station. This project was started in FY2025, but due to some delays in acquiring the generator and finding an electrician to complete the installation it is not scheduled to be completed until August. Once the project is completed, we can submit a disbursement request to the North Carolina Department of Environmental Quality for \$61,900.00.
