COUNTY MANAGER'S REPORT

July 14, 2025

Vacancy Report

There are currently 16 vacancies throughout county departments. There are 3 vacancies in Human Services (Nursing Supervisor, Eligibility Supervisor, Administrative Support Specialist), 4 within the Sheriff's Office (1 Detention, 1 Deputy Detective, and 2 Deputies), 3 within the Communications Department (Communications Shift Supervisor, Telecommunicator I, Communications Operations Manager) 4 in Emergency Services (3 EMT Paramedics and a Paramedic Crew Chief), one each in Central Permitting and Information Technology. Of these positions 6 have been vacant over 30 days and 1 has been vacant for over 100 days.

Facilities Master Plan

Met with department heads on Friday (07/18) to discuss establishing a Facilities Master Plan. The Facilities Master Plan will involve the formation of a Facilities Master Plan committee comprised of county staff to assist in inspecting county facilities and meeting with department heads to receive feedback on current facilities. The Facilities Master Plan will help identify opportunities to establish long-term plans for improving our county facilities, along with determining how to best manage our existing county facilities. We will start performing facility inspections in mid-August and will meet individually with department heads after facility inspections have been completed.

Opioid Settlements

New national opioid settlements have been reached with Alvogen, Amneal, Apotex, Hikma, Indivior, Mylan, Sun, and Zydus. Yadkin County will continue to monitor these settlements to work on trying to secure funding for the County from these most recent settlements.

Benesch Yadkin Parks & Recreation Planning

Benesch has been working with Parks & Recreation on developing a Comprehensive Parks & Recreation Master Plan. In addition, Benesch has been working on the Yadkin Memorial Park Master Plan and Yadkin County Park Master Plan. These planning efforts are focused on providing long-term improvements for residents that utilize our county parks. Once Benesch and county staff have finished reviewing and revising drafts, these plans will be presented to the Board of County Commissioners for their feedback.
