COUNTY MANAGER'S REPORT

September 15, 2025

Vacancy Report

There are currently 13 vacancies throughout county departments. There are 3 vacancies in Human Services (Eligibility Supervisor, Social Worker III, and Child Welfare Social Worker), 3 within the Sheriff's Office (2 Deputies and 1 Master Deputy), 2 within the Finance Department (Finance Purchasing Specialist and Finance Technician) 2 in Emergency Services (Paramedic and MIH Paramedic), 2 in Communications (2 Telecommunicator I), and one in Central Permitting (Senior Building Inspector). Of these positions 8 have been vacant over 30 days and 2 have been vacant for over 100 days.

Economic Development Director

The four-member interview panel met on Thursday (09/18) and interviewed the last four candidates for the new Economic Development Director position.

Preliminary Revised Flood Insurance Map

On Wednesday (09/17) I spoke with Thomas Tufts, NC Department of Public Safety Program Development Coordinator, regarding the preliminary revised Flood Insurance Rate Map and Flood Insurance Report for Yadkin County. The Preliminary Flood Insurance Rate Map and Flood Insurance Study include proposed flood hazard information for certain locations in the unincorporated areas of Yadkin County. Mr. Tufts informed me that there are more areas with decreases in the Special Flood Hazard Area rather than increases. There is a ninety-day appeal period where citizens can challenge the Preliminary Flood Insurance Map.

Annual Organizational Survey

The deadline for employees to complete the annual organizational survey was on Friday (09/19) at 12:00 pm. 182 employees completed the organizational survey. The survey results have been compiled and will be presented to the Board of County Commissioners at the October 6th Board of County Commissioners Meeting. In addition, the results will be distributed to all employees in the County.
