## **COUNTY MANAGER'S REPORT**

### **November 24, 2025**

#### **Vacancy Report**

There are currently 23 vacancies throughout county departments. There are 6 vacancies in the Human Services Agency (2 Eligibility Specialists, Eligibility Supervisor, Eligibility Fraud Investigator, Child Welfare Social Worker, and Public Health Education Specialist), 3 within the Sheriff's Office (2 Deputies and 1 Master Deputy), 13 in Emergency Services (7 Paramedics, 1 MIH Paramedic, 3 Paramedic Crew Chief, 2 Paramedic FTO), 1 in IT (IT Director). Of these positions 8 have been vacant over 30 days and 5 have been vacant for over 100 days.

#### **Personnel Policy Revisions**

County Administration and Finance staff have finished making proposed revisions to Yadkin County Personnel Policies. The personnel policy revisions were submitted to department heads on Wednesday (11/26) for their review. Department heads will have until January 9<sup>th</sup> to review and provide feedback on the proposed revisions. After January 9<sup>th</sup> the personnel policy revisions will be submitted to the Board of County Commissioners for their review and feedback.

#### **Low-Income Energy Assistance Program (LIEAP)**

The Low-Income Energy Assistance Program (LIEAP) is a federally funded program that provides for a one-time vendor payment to help eligible households pay their heating bills. Due to the recent Federal Government shutdown the Yadkin County Human Services Agency will not be accepting LIEAP applications until the funding is received. The program is not going to open on December 1st as in prior years, but an update will be provided to the public once we have more information when these funds become available.

#### **Yadkin River Greenway**

The Piedmont Triad Regional Council (PTRC) informed us that \$56,000.00 in federal funding is available to support a feasibility study for a Yadkin River Greenway. The Yadkin River Greenway would be a 13.5 miles multi-use path connecting the existing Jonesville Greenway and Rockford Road. The County would need to commit a \$7,000.00 match to support this feasibility study. The PTRC needs feedback on whether the County wants to proceed with a Request for Proposals for this Study. At the December 15, 2025, Board of County Commissioners Meeting the Board will determine whether they want to commit \$7,000.00 in matching funds to support this study.
