COUNTY MANAGER'S REPORT

December 1, 2025

Vacancy Report

There are currently 22 vacancies throughout county departments. There are 6 vacancies in the Human Services Agency (2 Eligibility Specialists, Eligibility Supervisor, Eligibility Fraud Investigator, Child Welfare Social Worker, and Public Health Education Specialist), 3 within the Sheriff's Office (2 Deputies and 1 Master Deputy), 13 in Emergency Services (7 Paramedics, 1 MIH Paramedic, 3 Paramedic Crew Chiefs, 2 Paramedic FTO). Of these positions 8 have been vacant over 30 days and 6 have been vacant for over 100 days.

Yadkin County Landfill Scale Improvements

Yadkin County Government in late October advertised a Request for Bids to install a new Solid Waste Scale at the Landfill (1149 Landfill Road, Yadkinville). On Friday (12/05) we held a pre-bid meeting at the Landfill with contractors interested in submitting bids on the scale installation project. The deadline to submit bids will be next Friday (12/12) at 12:00 pm.

LCID Landfill Facility

The North Carolina Department of Environmental Quality (NCDEQ) on Thursday (12/04) submitted a Letter of Approval for the Erosion and Sedimentation Control Plan for the LCID Landfill Facility at 1149 Landfill Road, Yadkinville. We are continuing to work with NCDEQ as we move through the LCID permitting process.

Golden Leaf Foundation Site Identification Grant

The Golden Leaf Foundation Board of Directors on Thursday (12/04) approved funding for our Site Identification application. We will work with Golden Leaf's engineering and site selection consultants to help identify future sites that could support industries in the County.

Onsolve CodeRed Data Breach

Yadkin County Government utilizes CodeRED alerts to inform citizens about emergency events that occur within the County. Onsolve CodeRED manages the CodeRED alerts platform. Onsolve CodeRED recently experienced a cybersecurity incident that created a national data breach for the company. At this time only contact information (name, address, e-mail address, phone numbers and/or associated passwords used to create user profile for alerts) for users has been accessed through this breach. We were informed

by Onsolve CodeRED on Wednesday (12/03) that Yadkin County users could be impacted by this breach.

NC OEMS System Plan Modification

The Board of County Commissioners at their meeting on Monday (12/01) approved the Elkin Rescue Squad Franchise Application to operate their ambulances within the County. On Tuesday (12/02) we updated the Office of Emergency Medical System Plan to incorporate Elkin Rescue Squad into the plan.
