**"Yadkin County Board of Commissioners after action Report for January 16, 2024"**

During the January 16, 2024 Board meeting, the Yadkin County Board of Commissioners took the following action:

- Held a Public Hearing for and approved a rezoning request located on W. Main St. / W. Old US 421.
- Approved Final Environmental Assessment for Rehabilitation of Dam 19A and 21 of the Deep Creek Watershed.
- Supported the Petition to add 310 ft. on Henry St. Ext, off SR 1145 Henry St., to the State maintenance system.
- Appropriated \$20,301 of Committed Fund Balance for equipment and striping of the Deputy Fire Marshal's replacement truck and released the remaining \$7,699 of Committed Fund Balance.
- Appropriated funds received from the State in FY2023 for Medicaid Expansion for the purchase of computers and office equipment for new staff positions.
- Approved payment of a previous year invoice from Human Services.
- Added the classification of Child Support Supervisor to the Classification and Pay Plan at pay grade 69, and reclassified Child Support Agent position #630042.
- Approved a contract with S&ME for construction materials testing and special inspection services for the construction of the new Government Building and EMS Outpost.
- Approved two contract amendments with W. Brown Construction for renovations to the old dental clinic to be used at Medic 5.
- Approved a contract with Kenco Electric Inc. to provide an uninterrupted power supply and battery backup for the E-911 backup center.
- Approved a contract for a renewed lease agreement for postage machines to be located at Finance, Central Permitting, and the Board of Elections.
- Approved a budget amendment allocating Building Reuse Grant monies.

During her Manager's Report, Lisa Hughes requested and received approval of a contract for abatement services for 102 E. Elm St. and a budget amendment to replace an engine in an ambulance. She also updated the Board on several grant applications and State Directed Grants as well as a potential request for state funds to be used toward a new VIPER tower and radios.
