Thank you for your interest in serving as a precinct official in Yadkin County. Each Election, precinct officials help us ensure that voters experience honest, accurate, and fair elections. Without your help, we would not be able to accomplish this end.

On Election Day, Precinct Officials are stationed throughout the County in various Community Buildings. Every precinct is staffed with a Chief Judge, two Judges, and Assistants. No person who is an Elected Official, Candidate for nomination, Officer of a Political Party, Treasurer for a Candidate, or near relative of a Candidate may serve as a precinct official.

Precinct Officials are required to attend a training session prior to Election Day. Election Staff will explain job responsibilities and give workers first-hand experience with the voting equipment. On Election Day, precinct officials will set-up the voting enclosure, greet voters as they arrive, process voters using Election software, issue management, and other administrative duties as assigned.

For your service, precinct officials will be compensated as follows:

- Chief Judge: \$15 per hour, \$100 supply pickup/drop off, \$25 training
- Judge: \$15 per hour, \$25 training
- Assistant: \$15 per hour, \$25 training
