“Yadkin County Board of Commissioners After-Action Report for January 5, 2026.”

During the January 5, 2026 Board meeting, the Yadkin County Board of Commissioners took the following action:

- Approved budget amendments for the Animal Shelter, Sheriff’s Office, Public Buildings, Governing Body, and EMS.
- Approved transfer of \$71,927.00 in Capital Projects to Special Revenue Fund.
- Approved Rural Economic Development Legally Binding Commitment to support sewer expansion for Advantage Machinery. The Rural Economic Development Legally Binding Commitment would involve \$142,500.00 being awarded from the North Carolina Department of Commerce to support the project.
- Approved the agreement between Yadkin County and the Economic Development Partnership (EDP) requiring that the Economic Development Partnership reimburse the County for the \$48,500.00 local government funding match provided to the Advantage Machinery Sewer Expansion Project.
- Approved the Dorsett Heating & Air Conditioning Contract to install a new HVAC at the Public Buildings facility for \$11,500.00. Public Buildings current HVAC unit is 29 years old and has a freon leak in the coil. The existing unit utilizes R-22 freon which is very expensive to purchase and use.
- Approved the Lone Hickory Solid Waste Convenience Site Lease Agreement. The Site Lease Agreement expired and needed to be renewed with updated terms. The new Site Lease Agreement will expire on January 5, 2036.
- Approved Northwoods Consulting Partners Contract to have them perform a one-time server migration for the Human Services Agency for a total of \$5,662.00.
- Agreed to provide a quarterly contract renewal for the Boonville Community Volunteer Fire Department. The quarterly contract will provide \$73,738.75 in funding to Boonville Community Volunteer Fire Department.
- Approved Bid and Budget Amendment for Charlotte Scale to install a new scale and steel deck at the Solid Waste Landfill (1149 Landfill Road, Yadkinville, NC 27055) for \$125,421.10.
